All those NEET – PG 2022 qualified candidates, whose names figured in Provisional Merit List (PML) of MD/MS Courses-2022 and are interested for admission to MD/MS Courses of ASCOMS under Hindu Minority and NRI management quota seats are advised to submit their documents on the prescribed Performa (**Annexure-A and Annexure-B**) along with all relevant/required documents physically in BOPEE office Srinagar/Jammu **w.e.f. from 7th November 2022 to 9th November, 2022** details of which are given below:

Note-1.

- *Hindu Minority (HM) seats under management quota shall be filled up from the NEET-PG qualified candidates belonging to Hindu Religion only with the condition that they shall produce latest relevant document/certificate issued by the concerned competent authority.
- ** NRI seats shall be filled up on the basis of merit cum preferences provided the necessary NRI documents are complete in all respects.
Only such candidates shall be considered under NRI/Hindu Minority quota who are:
 - Domicile of J&K;
 - have applied under NEET-PG 2022 and have qualified; and
 - have been found eligible to participate/compete against the J&K seats;

The eligibility criteria for competing under NRI quota seats shall be as under:-

(Category 1): Where applicant himself/herself is NRI and family originally belongs to J&K.

(Category 2): Children/Ward of NRI who originally belong to UT of Jammu and Kashmir.

Any other condition as notified by the Government of India/ Government of J&K or any direction given by the Hon'ble Supreme Court, of India, in this regard to compete for such seats.

Documents Required for NRI Category 1 and Category 2 candidates:

Category No. 1:

- (i) NEET PG Score Card-2022;
- (ii) NRI certificate issued by the Ministry of External Affairs, Government of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport;
- (iii) NRI Bank Account preferably in the country where the candidate is residing or of NRI Account in India;
- (iv) Copy of Indian Passport;
- (v) Copy of Income Tax Return filed in India, if any;
- (vi) PAN Card, if any; and
- (vii) Domicile Certificate of the candidate belonging to J&K.
- (viii) Any other document as may be required by the Board to its satisfaction.

Category No. 2:

- (i) NEET PG Score Card-2022;
- (ii) NRI Sponsorship Letter;
- (iii) Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian Embassy Overseas;
- (iv) Bank Statement of the Sponsor;
- (v) Resident/National Certificate or NRI certificate of the sponsor;
- (vi) Pedigree Table/Family Tree establishing relationship of the candidate with the sponsor along with documentary Proof;
- (vii) Employment certificate of the sponsor;
- (viii) PAN Card , if any of the sponsor;
- (ix) PAN Card, if any of the candidate/parents;
- (x) Copy of Income Tax Return filed, if any;
- (xi) Domicile Certificate of the candidate belonging to J&K.

The prescribed formats **Annexure "A" and "B"** to this Notification shall be available only on BOPEE website www.jkbopee.gov.in

Note-2:-

1. The above documents are required in addition to all other documents that candidates were required to submit as notified in earlier notifications through online mode and in conformity with the e- Information Brochure.
2. The above categories are not priorities but for determination of eligibility only and the seats shall be filled up on the basis of NEET Merit.
3. The fee shall be as notified in Information Brochure or as may be notified by the Government of J&K from time to time.

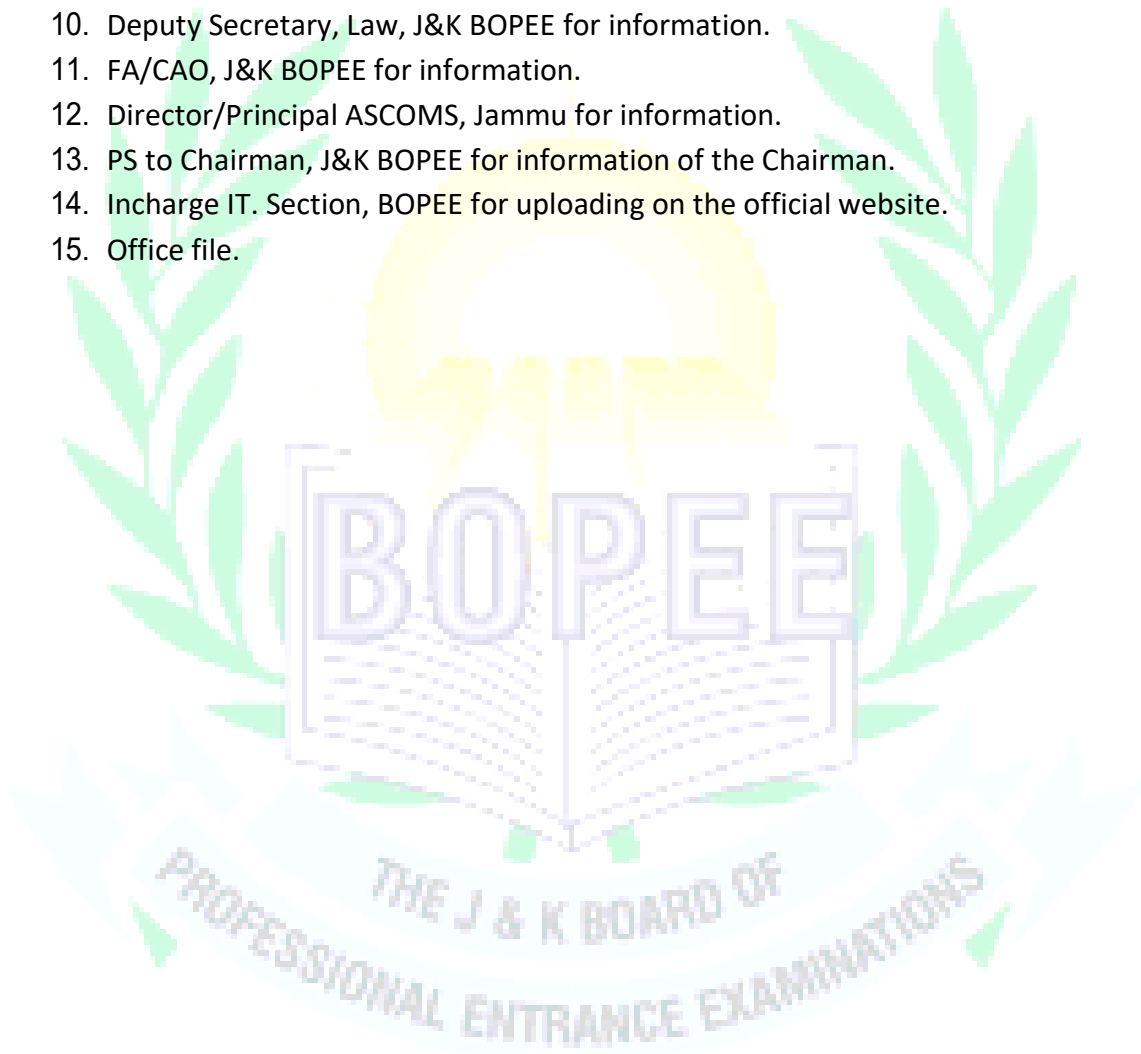

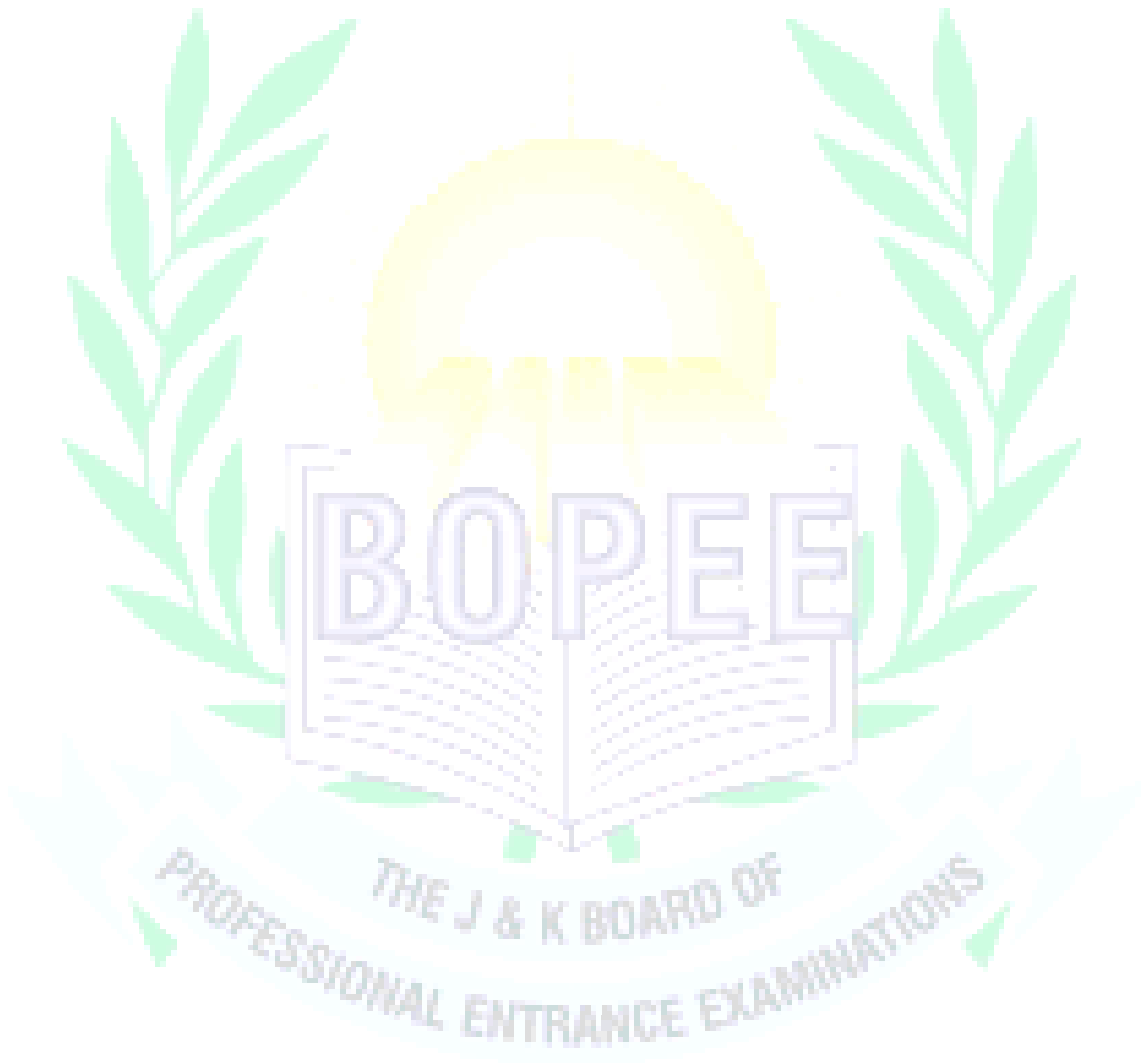
