**Dated 07-11-2022**

In pursuance of Notice No. 029-BOPEE of 2022 dated 04.11.2022, it is hereby notified that the Board shall conduct the 2<sup>nd</sup> Round of up-gradation and allotment counselling (Physical) on 09.11.2022 for filling up of MD/MS/PGD and MDS seats available in Government Medical College, Jammu, Government Medical College, Srinagar, SKIMS Soura Srinagar, ASCOMS, Jammu Government Dental College Jammu respectively.

In addition to the seats of MD/MS/PGD already notified vide above mentioned notice, one seat of MDS in Oral and Maxillofacial Surgery under SC category which has been received as shortfall from GDC Jammu after the first round of counselling shall also be filled during this round of counselling.

The eligible and willing candidates are advised to report at BOPEE Office Srinagar/Jammu from 8.30 am to 10.30 pm for registration, attendance and fulfillment of other counselling related formalities on the day of counselling.

The Board shall first fill up the vacant seat of MDS Course, followed by filling up of vacant seats of MD/MS/PG Diploma Courses 2022.

**Note.**

- As already notified the candidates who have been allotted seat during first round online counselling and have joined in the allotted Colleges/ Courses shall be eligible for up-gradation. The candidates who have not been allotted any seat during the said round of counseling shall also be eligible for participation in this round of counselling. The candidates who have been allotted seat (s) during 1st round of online counselling but have not joined the Colleges /Courses shall under no circumstances be eligible to participate in the 2<sup>nd</sup> round of counselling.
- The newly registered candidates, if any, after lowering of cut of score and any other eligible candidates who do not figure in UT Merit list but have submitted their documents physically at BOPEE office Srinagar / Jammu upto the cutoff date i.e. 07.11.2022 in pursuance of Notice No. 029-BOPEE of 2022 dated 04.11.2022 shall also be eligible for this round of counselling. They shall be placed at appropriate position in the UT merit list as per their merit position. However, they shall have to pay the offline counselling fee of **Rs. 2000/-** as already mentioned in the e-Information Brochure of NEET-PG 2022 through POS machine available at BOPEE Office Jammu/ Srinagar, before their registration and attendance.
- Mere registration of the candidates does not confer any right on them to claim for any vacant seat(s) which as of now are to be filled-up from the registered candidates on the basis of their merit/ preference.

- (d) The seat matrix for both MD/MS/PGD/MDS shall be uploaded on website of the Board in due course of time.

The other terms and conditions shall remain the same as contained in the e-Information Brochure, Notifications and Notices issued by the Board from time to time in this regard.
