Subject: - Admission to MBBS/BDS Courses-2022 along with HM Quota seats in ASCOMS Jammu: Conduct of Mop-up round thereof. Reference: -Notification No. 091-BOPEE of 2022 dated 26-11-2022.

Notification No. 100-BOPEE of 2022 Dated 08-12-2022

Consequent upon completion of second round of upgradation/allotment counseling for admission to MBBS/BDS Courses 2022 along with HM quota seats in ASCOMS Jammu, it is hereby notified that the Board shall conduct the Mop up round (physical) for these courses as per the following schedule for filling up of unfilled seats and the seats that remained vacant due to non-joining of candidates and were received as short fall from various Medical Colleges/ Institutions: -

The eligible candidates have to report to the BOPEE office Jammu / Srinagar for registration and fulfillment of all formalities, from 8:30 A.M. upto 10:00 A.M. on the day and date of counseling.

It is further notified that the candidates may go through the Notification carefully as only the following candidates shall be eligible to participate in the mop up round of counseling and in case of non-fulfillment of the conditions mentioned herein below such candidate(s) are not eligible to participate in mop up round: -

- 1. The candidates who have not been allotted any seat during the 1st/ 2nd round of counseling shall be eligible to participate in the mop-up round in terms of conditions contained in the Information Brochure.
- 2. The candidates who have been allotted a seat during 1st round of counseling and have joined the college but have not been upgraded during the 2nd round owing to less merit are allowed to participate in the mop-up round. Those candidate(s) who have been allotted seat during the 2nd round of counseling and have joined the college/institution and want to participate in the mop-up round for purpose of up-gradation are also eligible to participate in the mop-up round. Further any candidate who has been allotted a seat during First round of counseling but has not joined against the allotted seat / college shall also be eligible for Mop up round. However, any candidate upgraded during the 2nd round of counseling shall under no circumstances be eligible to participate in the mop-up round.
- The candidates who have been allotted seat in AIQ mop-up-round and have joined the respective allotted College / Institution shall not be eligible to participate in this mop-upround.

- 4. The candidates who will be upgraded/allotted seats during the mop-up round shall have to mandatorily join the College/ Institution upto the last date of joining as fixed by Board.
- 5. The candidates should go through all the relevant Notifications/Notices along with the e-Brochure notified by the Board with particular reference to the mop-up round of counseling;
- 6. The Board shall first conduct the counseling of reserved category candidates.
- 7. If any reserved category seat(s) remain unfilled due to non-availability of eligible candidates, then those seats shall be converted into OM in terms of Section 9(2) of J&K Reservation Act-2004 and shall be filled up accordingly as per merit.
- 8. If any EWS seat(s) remains vacant for want of any eligible EWS candidate, the same shall be allotted to open (OM) candidate on the basis of merit cum-preferences during this mop-up round of counselling.
- 9. The category candidate(s), who may not get a seat in his/her category shall be eligible to participate in the counseling as an OM candidate as per his/her merit subject to the condition that he / she falls within the cut off score of OM.
- 10. One Female seat of MBBS in GMC-Baramulla under CDP category which has been kept blocked on the Court Orders shall be filled up during Mop-up round but the allotment letter shall be issued to the candidate only after the final disposal / outcome of the Writ petition titled Saanvi Andotra V/s Union of India.
- 11. The tentative details of seats to be filled during mop-up round of counselling is annexed as Annexure "A" to this Notification for the information of the candidates to facilitate them to decide to report for the counselling.
- 12. The seats available in DDH and DDM available in Govt. Dental College Jammu and Srinagar shall be filled on the basis of merit cum preference and not on the basis of gender.

The final seat matrix shall be made available on the website of the Board in due course of time.

The other terms and conditions shall remain the same as contained in the e-information Brochure, Notifications and Notices issued by the Board from time to time in this regard.
