**Further, the candidate(s) who had offered their preference for Lateral Entry on the basis of requisite qualification i.e. ANM/FMPHW/MMPHW though figuring in the provisional Merit list annexed as Annexure-A to Notification No.101-BOPEE of 2022 Dated.09.12.2022, shall not be eligible for counselling during the above referred round of counselling scheduled to begin from 11.12.2022.**
