Consequent upon declaration of AIAPGET 2022 result on 09-11-2022, it is hereby notified for information of all those candidates who have qualified the said entrance examination and intend to participate in the counselling process for MD/MS Ayurveda seats in JIAR including All India Quota(AIQ) seats, that they shall: -

1. Register themselves online on the official website of BOPEE w.e.f. 17-02-2023 to 27-02-2023.
2. Upload all necessary documents on official website of BOPEE (www.jkbopee.gov.in) along with the result card of AIAPGET-2022 for verification by the Board.

Note:

- i. Cut-off of AIAPGET-2022 score:

OM/EWS/CDP/JKPM/SP	50 th Percentile (Cut-off score 109)
SC/ST/OSC/PSP/ALC/IB/RBA	40 th Percentile (Cut-off score 93)
OM/EWS-PwD	45 th Percentile (Cut-off score 101)
SC/ST/OSC/PSP/ALC/IB/RBA-PwD	40 th Percentile (Cut-off score 95)

- ii. The candidate shall have to fill the online preference in the Application form available on BOPEE website www.jkbopee.gov.in w.e.f 17th of February 2023 to 27th of February 2023.
- iii. The candidates have to deposit the Counselling fee of Rs. 2000/- (two thousand only) through online mode without which they will not be considered for allotment of a seat notwithstanding the eligibility of such candidate (s)
- iv. The seats shall be allotted to the candidates on the basis of merit cum preferences filled by the candidates in the online form.
- v. All Management Quota seats including All India Quota seats shall be filled up by the BOPEE in terms of Government Order No. 64-HME of 2019 dated 04.07.2019 issued by the Health & Medical Education Department, J&K.
- vi. The registration shall be provisional.
- vii. There is no reservation in the Private College but the candidates within cutoff eligibility score can participate in the Counselling and will be considered on the basis of their merit scored by them in AIAPGET examination.

- viii. Any wrong information filled by the candidate(s) in Application Form shall render him/her ineligible for admission.

Note 2:

- (i) The seats under All India Quota (AIQ) in Private Colleges shall have to be filled by State/UT Counselling Authority i.e. J&K Board of Professional Entrance Examinations as per counselling guidelines for admissions & counselling issued by All India Ayush Central Counselling Committee (AACCC) referred above. For these seats, no domicile certificate is required i.e candidate from outside UT of J&K can apply under All India Quota seats mentioned in above table subject to the eligibility as mentioned above.
- (ii) The seats under All India Quota (AIAQ), if any, remaining unfilled, due to non-availability of candidate(s) from outside UT of J&K, the Board shall fill and allot such seats to willing candidates belonging to UT of J&K.
- (iii) Regarding charging of Fees for Government /Management Quota/All India Quota Seats, the willing candidates are advised to contact the concerned College before participation in Online Counselling process.

- II. Domicile Certificate of the candidate;
- III. Final Year Marks Sheet of all BAMS Examination;
- IV. Documentary Proof of having completed one-year pre-registration Compulsory Rotatory Internship in a duly recognized institution at the time of submission of documents;
- V. Registration Certificate from J&K Medical Council/CCIM;
- VI. Degree Certificate of BAMS issued by the concerned University;
- VII. No Domicile Certificate is required for the candidates from outside UT of J&K who are applying for All India Quota seats.
