Online Applications are invited from the eligible/desirous candidates who intend to appear in the Entrance Test for admission to B.Sc. Nursing /B.Sc. Paramedical / B.Sc. Technology Courses for the academic session-2023 in Government / Private Colleges / Institutions of UT of J&K. The selection of the candidates to such courses shall be regulated by the J&K Board of Professional Entrance Examination Act, 2002 and the Rules and Regulations there under; Jammu & Kashmir Reservation Act, 2004 as amended vide J&K Re-organization Act, 2019, J&K Reservation Rules, 2005 as amended vide S.O. 69 dated 28-02-2020, S.O 127 dated 20-04-2020, S.O. 249 dated 23-07-2021, S.O. 277 dated 13-08-2021 and subject to further amendments, if any, made by the Competent Authority, from time to time and the guidelines as contained in the Electronic Information Brochure-2023.

1. Receipt of online application forms: w.e.f. **19-04-2023**.
2. Last date for filling the online application forms: **03-05-2023 (Midnight)**.
3. **Fee of Rs. 1000/ (Rupees one thousand only)** to be paid online through National Credit Card/Debit Card/Net Banking.
4. The e-Information Brochure can be downloaded from the BOPEE website viz [www.jkbopee.gov.in](http://www.jkbopee.gov.in)
5. The syllabus for the examination/test is available in the e-Brochure.
6. Date of Common Entrance Test: (to be notified separately).
7. The candidates, in their own interest, are advised to go through the Information Brochure before filling up the Online Application Form. The Board shall not be responsible for any act of omission or commission in filling up of the Online Application Form by the candidate(s). It is incumbent upon the candidates to go through the information contained in the e-Information Brochure and agree to the conditions contained therein.

9. The Entrance Examination, if any, conducted by the Board shall be offline.

**Submission of Online Application Forms:**

The interested candidates are required to upload the following scanned original / self-attested certificates in PDF format with size from **100-200 KB** along with the Application Form: -

- (i) domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates of UT of Ladakh, ST certificate issued by the Competent Authority of Ladakh shall be treated as Domicile Certificate),
- (ii) Qualifying marks (12<sup>th</sup> Class) certificate; (where result is declared),
- (iii) Date of Birth Certificate (only Matriculation Certificate issued by the Board); and
- (iv) Valid Reserved category certificate, if any,
- (v) Any other documents, as requested.

However, it is for the information of all the concerned that afore-titled documents as required for submission of application form shall be considered provisional and subject to change(s), if any, as may be notified by the Government subsequently.

**A. Eligibility for B.Sc. Nursing Programme:**

The candidates applying for admission to B.Sc. Nursing Programme must fulfill the following eligibility criteria;

A candidate must:

- (i) be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, ST certificate issued by Competent Authority of Ladakh shall be treated as Domicile certificate);
- (ii) be 17 years old on 31st December of the year in which admission is sought.
- (iii) have passed the qualifying 12th Standard examination (10+2) and must have obtained a minimum of 45% marks in Physics, Chemistry and Biology taken together and passed in English individually including the candidates from State

Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government having Science subjects and English only.

- (iv) For the candidates belonging to reserved categories, the marks obtained in 3 core subjects shall be 40% instead of 45% for General category candidates.
- (v) The candidate must be medically fit.

Further the candidates appearing/appeared in 10+2 (12<sup>th</sup> Class) examination 2023 can also apply, provided such candidates have qualified the examination at the time of declaration of the result of the Entrance Test or before the date of counseling/admission as may be notified by the Board;

#### **B. Eligibility for B.Sc. Para-Medical Courses:**

The candidates applying for admission to B.Sc. Para-Medical Courses must fulfill the following eligibility criteria;

A candidate must:

- (i) be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, ST certificate issued by Competent authority of Ladakh shall be treated as Domicile certificate);
- (ii) be at least 17 years old on 31<sup>st</sup> December-2023;
- (iii) have passed 10+2 or equivalent examination with Science (PCB) and English through a recognized Board / University securing minimum 50% marks and above for Open Merit Candidates and 40 % marks and above for candidates belonging to Reserved Categories in aggregate;

Further, the candidates appearing/appeared in 10+2 (12<sup>th</sup> Class) examination; 2023 can also apply, provided such candidates have qualified the examination at the time of declaration of the result of the Entrance Test or before the date of counseling/admission as may be notified by the Board;

The candidates applying for Lateral Entry only must have obtained diploma in concerned stream and having passed 10+2 with Physics, Chemistry, Biology and diploma registered with J&K Para-Medical Council.

#### **C. Eligibility for B.Sc. Technology Courses in SKIMS, Soura, Srinagar:**

A candidate must:

- a. be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, ST certificate issued by Competent authority of Ladakh shall be treated as Domicile certificate);
- b. be at least 17 years old on 31<sup>st</sup> December-2023,
- c. have passed 10+2 or equivalent examination with Science (PCB) and English through recognized Board / University securing minimum 50% marks and above for Open Merit Candidates and 40% marks and above for candidates belonging to Reserved Categories in aggregate;

Further, the candidates appearing/appeared in 10+2 (12<sup>th</sup> Class) examination 2023 can also apply, provided such candidates have qualified the examination at the time of declaration of the result in the Entrance Test or before the date of counseling/admission as may be notified by the Board;

**Syllabus:**

The candidates applying for the courses mentioned above at (A), (B), (C), are advised to go through the syllabus for Common Entrance Test referred to in e- information brochure of B.Sc. Nursing/ B.Sc. Paramedical / B.Sc. Technology Courses available on BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in).

**Note - I**

The eligibility is bare minimum/provisional and shall be subject to such changes/bench marks as may be fixed by the concerned Competent Authority/ University. The Board shall on receipt of any such communication from the concerned authority/University notify the same, which shall govern the eligibility criteria.

**Original Documents required to be submitted in the Institution at the time of Admission: -**

- a) Marks certificate of the qualifying examinations (12<sup>th</sup> class marks certificate);
- b) Date of birth (Matriculation / Secondary School Certificate) from a recognized Board;
- c) Domicile Certificate for candidates belonging to UT of J&K and ST certificate as a Domicile for candidates belonging to UT of Ladakh;
- d) Category Certificate, if any;
- e) Any other document as may be required by the Institution.

**Roll No Slip/Admit Card:**

The Notification for downloading of online electronic Admit Cards will be issued separately.

**Venue for Conduct of Examination:**

The Common Entrance Examination, if any, shall be conducted offline at Jammu / Srinagar centres simultaneously as may be decided by the Board.

**Issuance of Admit Cards and Date of Test (if test is conducted):**

Information with regard to availability of Online Admit Cards, Venue and Time of the Common Entrance Test will be issued separately in due course of time.

**Note-II**

1. The online submitted Application Form is purely provisional and is liable to be cancelled at any stage subject to the final verification of the documents and even at any stage, where such a document is proved to be fake/false.
2. In case the Board shall not conduct the entrance test, the selection of the eligible candidates shall be made on the basis of the percentage of the marks obtained in the qualifying examination.

3. The candidature of those candidates, who may have submitted incorrect / wrong application form during online process, shall be liable to be rejected without any further notice to such candidates. However, they can rectify their correction(s), if any, by submitting a representation physically at BOPEE office Jammu / Srinagar on or before last date fixed by Board for filling up of online application forms.
4. Mere submission of the Application Form and appearance of the aspiring candidate in the Entrance Test shall not confer any preferential right/claim for admission upon the intending applicants, but shall be subject to the fulfillment of the eligibility criteria and the qualification prescribed for the said course.
