



# Subject:- Allocation of MBBS/BDS Seats from Central Pool for spouse and children of terrorist victims for the academic year 2023-24.

# Notification No. 059-BOPEE of 2023. Dated: 13 -08-2023

Pursuant to communication No.17015/71/2023-CT-II dated 09.08.2023 from Ministry of Home Affairs, Government of India, Offline applications are invited from eligible candidates on prescribed format annexed as Annexure-A to this notification for allocation of MBBS/BDS Seats from the Central Pool for Spouse and Children of Terrorist Victims for the academic year 2023-24. Briefly the eligibility is reproduced as under:-

## **Eligibility Conditions:**

Only the children of

i. Permanent residents of the State/UT concerned;

ii. The employees of the State/UT Government concerned;

iii. the employees of the Central /Other State / UT Government on deputation to the State /UT concerned and

iv. the employees of the Central /Other State / UT Govt. posted in and having their headquarters within the State/UT concerned will be eligible.

The children of Central/State/UT Government employees aforementioned should be treated at par with the local resident.

# **Educational Qualification.**

As per Graduate Medical Education Regulation of National Medical Commission, the candidate must have passed in the subjects of Physics, Chemistry, Biology and English individually and must have obtained a minimum of 50% marks (40% for SC/ST/OSC/PSP/ALC/IB/RBA & 45% for General PH and 40% for SC/ST OSC/PSP/ALC/IB/RBA-PwD category candidates) taken together in Physics, Chemistry, Biology/Bio-Technology at the qualifying examination.

# Selection of Candidates.

The selection of candidates will be made on the basis of rank obtained in the National Eligibility-cum-Entrance Test (NEET) -2023 being conducted by the National Testing Agency (NTA). As per Graduate Medical Education Regulations 1997 of Medical Council of India, it shall be necessary for the candidates to obtain minimum marks at 50<sup>th</sup> percentile at NEET-2023. However, in respect of candidates belonging to SC/ST OSC/PSP/ALC/IB/RBA, the minimum marks shall be at 40<sup>th</sup> percentile. In respect of candidates with specified disabilities, the minimum marks shall be at 45<sup>th</sup> percentile. The percentile shall be determined on the basis of highest marks scored in the All India Common Merit List in National

Eligibility-cum- Entrance Test for admission to MBBS/BDS Courses.

## **Reservation.**

The Reservation Policy being followed by the UT's of J&K Ladakh shall apply on Central Pool MBBS/BDS Seats.

- (II) The last date of submission of application (s) in duplicate is 18.08.2023 (till 3.pm). The same shall be submitted/ deposited by the eligible candidates at J&K BOPEE offices Jammu/Srinagar physically upto the prescribed date and time.
