It is hereby notified for the information of all the concerned candidates that the Ministry of Health & Family Welfare, Government of India vide Notice No. U-12021/02/2023-MEC dated 20-09-2023 has lowered the qualifying percentile for PG courses (Medical/Dental) for NEET PG counselling-2023 to “**Zero**” across all categories for the academic year 2023-24.

The candidates who fall within the ambit of the said revised percentile score and are willing to participate in the 2<sup>nd</sup> round of Upgradation/Counseling against the seats which have remained unfilled during 1<sup>st</sup> round of counseling are advised to register themselves and submit all the requisite documents as mentioned in Notification No. 053-BOPEE of 2023 dated 10-08-2023 physically at BOPEE office Jammu/Srinagar within **03 days** of uploading of this Notice on the official website of the Board and any eligible candidate who has not registered earlier and does not figure in the annexure of Notification No.081-BOPEE of 2023 dated:18.09.2023 in the UT Merit list of 2023, but wants to be considered himself/herself against the unfilled seat/seats

during 2<sup>st</sup> round of counseling may also submit his/her documents physically at BOPEE office Jammu/Srinagar for registration within the prescribed time schedule indicated here in above.

Further those candidates whose candidature was earlier rejected due to score below cut off may be considered now as eligible after lowering of cut off score by Ministry of Health & Family Welfare, Government of India.

Note:

1. Mere registration of candidates does not confer any right on any candidate(s) to have a claim on any vacant seat(s) which as of now are to be filled up on the basis of the merit/preference of the candidates from eligible/registered candidates
2. The candidates should go through all relevant Notifications/Notices notified by the Board with particular reference.
3. Seat Matrix shall be uploaded a day before start of counseling
4. The other Terms/Conditions and eligibility shall remain the same as contained in the e-Information Brochure, Notifications/ Notices issued by the Board from time to time in this regard.
