Note:-

- National Board of Examinations vide Public Notice dated 27-04-2018 have reduced the qualifying
 percentile for OM candidates to 262 and for category candidates to 225. Therefore, such candidates who
 fall within said cut off score shall also be eligible to participate in the mopping up round but shall be
 considered only after the candidates from the provisional merit list notified by the Board vide Notification
 No. 017-BOPEE of 2018 dated 15-03-2018 read with Notification No. 018-BOPEE of 2018 dated 20-032018 are not available;
- Such candidates shall be required to register themselves with the BOPEE Office, Jammu/Srinagar (as per Annexure to this Notification) and deposit the documents as were otherwise required by uploading vide Notification No. 019-BOPEE of 2018 dated 20-03-2018 w.e.f. 03-05-2018 to 08-05-2018. A separate supplementary merit list of such candidates shall be prepared.



- 3. Such candidates shall be required to produce original documents also for verification in the BOPEE Office, Jammu/Srinagar upto the prescribed date.
- 4. The Other terms and conditions of the eligibility shall remain the same as notified by the BOPEE from time to time.
- 5. Such candidates willing to participate in the mopping up round shall be required to deposit a fee of Rs.2000/- through POS machine in the BOPEE Office, Jammu/Srinagar..
- 6. The terms and conditions in the Information Brochure for upgradation ground/physical round/mopping up round shall remain the same.
- 7. The candidates are advised to go through the eligibility conditions contained in the Information Brochure before participating in any future round of counseling.
- 8. Board shall not be responsible in any manner for any lapse committed by any candidate.
- Candidates who have not participated in the first round of counselling and are willing to participate in the upgradation/allotment round shall have to deposit a fee of Rs.2000/-. Such a facility shall be available online also during the online upgradation round.
- 10. Option once exercised cannot be withdrawn.
- 11. It is reiterated that the candidates in their own interest are advised to remain in touch with the BOPEE website www.jkbopee.gov.in for updates, as it would not be possible for the Board to have the notices published at short notices.
- 12. The candidates eligible and desirous of participating in physical rounds of counselling shall be required to register their names at 9 a.m. in the BOPEE Office on the day of counselling and shall have to follow the procedure contained in Information Brochure.
- 13. The last date for submitting resignation shall be 09-05-2018 (5 p.m.) and candidates resigning after the said date shall be disqualified for participation in the future admission process in accordance with the rules.
- 14. The above changes shall form part of Information Brochure notified by the BOPEE vide Notice No. 012-BOPEE of 2018 dated 21-02-2018 as the admission schedule has been harmonized with the schedule notified by the MCI by making necessary adjustments.
