Subject:- Submission of resignation and relaxation in participation in the mopping up round.

Notice No.034-BOPEE of 2018

Dated: 09-05-2018

During the upgradation round held on 09-05-2018 following issues were flagged by the competing candidates:-

- i) The time for submission of resignation may be extended upto 10-05-2018;
- ii) The candidates who have been allotted a seat during the first and subsequent rounds may be allowed to participate in the mopping up round in view of extra-ordinary situations/litigations etc.

The matter has been examined by the Board and it has been decided as under:-


- 1) The time for submission of resignation is now extended upto 10-05-2018 2.00 p.m. The candidate shall be required to submit resignation only in the college and college shall forward the same to the BOPEE upto 3.00 p.m. on 10-05-2018;
- 2) Majority of the seats have been filled by the Board i.e. 469 seats during the first round of counselling and 54 candidates were upgraded during the second round of upgradation and 56 candidates were allotted seats afresh during that round. During the physical round being held today residual seats have become available, which were notified also. The Board does not anticipate large number of resignations by the candidates and, therefore, it has decided that the candidates who are otherwise eligible can participate in the mopping up round notwithstanding whether such a candidate has participated earlier or not. This is being done in relaxation of the procedures notified by the Board. Further, the Board shall not take any undertaking/responsibility in case the candidate fails to join the college/institute if allotted a seat during the mopping up round as Board cannot go beyond the schedule notified by the MCI i.e. 12-05-2018. This is despite the fact that the Board had taken up the

matter with the MCI to extend the time schedule of admission to MD/MS/PG Diploma course, which they did not extend. Further, the Board had submitted an application before the Hon'ble Supreme Court to extend the time schedule which has also not been granted so far;

- 3) The candidates allotted a seat during mopping up round shall have to join the College/Institute and in case of non joining for any reason, he/she shall be disqualified in terms of SRO 48 of 2018 dated 30-01-2018. This shall also apply to those upgraded, if any, during the mopping up process.
