Pursuant to Notification No.098-BOPEE of 2023 dated:18.10.2023 & No.118-BOPEE of 2023 dated 18.11.2023, the Board has received the shortfall of seats from Institute of Advance Studies (formally Government College of Education) M. A. Road Srinagar/ Composite Regional Centre (CRC), Bemina Srinagar and Government College of Education, Canal Road, Jammu respectively. In order to fill the seats received as shortfall and the seats which have remained vacant after the conclusion of first round of counselling, it is hereby notified for information of all concerned candidates that the Board shall conduct the Second Round (Upgradation/Allotment) of Counseling (Physical) on 1St of December, 2023 as per the following schedule:-

The eligible candidates shall have to report at the BOPEE offices Jammu / Srinagar for Registration/Attendance and fulfillment of other formalities, from **11.00 a.m. to12.00 Noon** on the day/date of counseling for above Courses.

It is further notified for information of all the concerned candidates that the upgradation/allotment of seats during the Second Round of Counseling shall be purely on provisional basis and shall not confer any preferential right on the provisionally selected candidates and shall be subject to the outcome of writ petition, if any, pending in any competent court of law on the subject.

All the candidates who are participating in the counseling shall bring along the following documents in original on the day of their counseling failing which they shall not

be allowed to attend the counseling:

- i) Domicile certificate,
- ii) Final year Marks card of Graduation.
- iii) Category certificate, wherever applicable.

Note -I:

The following procedure shall be followed during the conduct of Second Upgradation/ Allotment Round of Physical Counseling:-

- 1. All the CDP candidates shall have to bring along their Priority certificate for check / verification at the time of counseling.
- 2. It is enjoined upon all the eligible candidates that they shall visit/ attend counseling only after checking the Seat Matrix available on the official website of the Board.
- 3. Those candidate(s) who have been allotted seat(s) during the First Round of Counseling and have joined against the said seat / College, if interested, for upgradation from IASE, Srinagar to CRC, Srinagar or vice versa are eligible to participate in the Second Round of Physical Counseling with the condition that he/she shall have to produce his/her fee deposition receipt of the concerned allotted College at the time of Registration/Attendance on the date of counseling.
- 4. The eligible candidates who have failed to participate in the First Round of counselling due to one or the other reason shall also be eligible to participate in this round of counselling.
- 5. The candidate(s) who have been allotted Seat(s) during the First Round of counseling, but have failed to join, he/she shall not be eligible to participate in the Second Round of counseling.
- 6. The candidates who are participating for the first time in the counseling process shall have to deposit Rs.1000/ as a Counseling fee through POS machines available at BOPEE office Jammu / Srinagar on the date of Counseling.
- 7. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.

Note -II:

The Seat Matrix for 2nd Round of counselling shall be uploaded on website of the Board before the day of counseling for information of the candidates.

The counseling shall be stopped as and when all the seats shall exhaust and no claim(s) from the waiting candidates, if any, shall be entertained by the Board.

The other Terms and Conditions shall remain the same as notified by the Board in various Notifications/Notices issued from time to time in this regard.
