2. Marks Card of the requisite Courses passed by the candidate.
3. Degree Certificate.
4. Date of birth (10th class marks card/Diploma issued by the Board).
5. Experience/Work Certificate wherever required.
6. Valid Reserved Category Certificate, if any and;
7. Any other document/Certificate as may be required by the Admission Authorities of the Institute.

Note:

1. As per Section 9(2) of the J&K Reservation Act 2004, 11 seats available in various Reserved Categories were converted to Open Merit due to non- availability of eligible candidate(s) in the respective Reserved Categories and were allotted to the eligible candidates strictly on the basis of merit/preference Course wise as per the eligibility fixed by the SKIMS.
2. The admission of the candidates is purely provisional and shall be cancelled in case any information furnished by any candidate proves to be false/fabricated and action as warranted under Law shall be initiated against such candidate(s).
3. It is hereby implored upon the Management of the SKIMS to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a Reserved Category.
