Consequent upon the receipt of shortfall from Engineering Colleges/Institutions and the seats that remain vacant after conclusion of second round of Physical Counselling in various disciplines of B.E/B.Tech (Engineering) courses 2024-25, it is hereby notified that the Board shall conduct Third/Mop-Up Round (Upgradation/Allotment) Physical Counselling for admission to B.E/B.Tech Courses-2024 in various Government/Private Colleges/ Institutions of UT of J&K simultaneously at BOPEE office, Jammu/Srinagar w.e.f 29-07-2027 as per the schedule given below:

The Upgradation/Allotment of seats during the third/Mop-up round shall be strictly on the basis of merit cum preferences filled up by the candidates on the day of Counselling in their Counselling forms.

Candidates Not Eligible to participate in the third (Mop-up) round of Physical counseling:

- ➤ The candidates who have not joined the discipline/institution allotted in the second round of counseling;
- > The Candidates who have been upgraded to different discipline/institution in the second round of physical counseling and have joined the same;
- Candidates who have cancelled (withdrawn) their admission after joining the discipline/institution allotted to them in the first or second round of physical counseling.

Candidates Eligible to participate in the third(Mop-up) round of Physical counseling:

- ➤ The candidates who have been allotted seat during second Round of Counselling and have joined against the said seat/college and are now willing to get upgraded.
- ➤ Those Candidates who remained absent or have opted CNA/SNA during 1st or 2nd round of Counselling shall be eligible to participate in this third/Mop-up Round of Counselling;
- ➤ The candidates who have been allotted discipline/institution only in the first round of counseling, but could not join the same.

Note:

- 1. All the participating candidates are advised to bring the following documents in original for check and verification at the time of Counselling:
 - a. Domicile certificate;
 - b. 12th class Marks card (whose results are declared);
 - c. Valid Category Certificate, if applicable,
 - d. Date of Birth Certificate (Diploma/10th class Marks certificate);
- 2. The candidates participating for the first time in the Counselling have to deposit an amount of **Rs. 1000/-** as a Counselling fee on the day of Counselling through POS Machines available at the BOPEE Offices, Jammu/Srinagar through Debit/Credit Card.
- 3. It is enjoined upon all the eligible candidates that they shall visit/attend Counselling only after checking the Seat Matrix to be made available on the official website viz www.jkbopee.gov.in of the Board before the day of counselling.
- 4. The candidates reporting for the upgradation shall have to bring receipt of admission fee deposited in the allotted college for check/verification during the counselling.
- 5. The candidate(s) participating in this physical round of counselling and getting allotted a seat, should in their own interest not to leave the Board office as there is a possibility that a seat of his/her choice, which was not available on his/her turn of counselling may become available during the process, he/ she can stake a claim on such a seat immediately once the seat is displayed in the seat matrix on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis. The seat allotted to him/her earlier shall become vacant and be added to the seat matrix. The Board shall not be responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as discussed above.

- 6. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.
- 7. Seat matrix shall be uploaded separately within due course of time before counselling and all the participating/eligible candidates are advised to go through seat matrix before participating in the counselling process.
- 8. Candidates who have failed to upload the TFW Certificate at the time of filling up of online Application form are also eligible for admission under TFW category subject to the production of valid TFW certificate issued by the Competent Authority at the time of counseling.

The other terms and conditions shall, however, remain the same as notified by the Board in various Notifications/Notices and e-informations brochure in this regard.
