Consequent upon the declaration of the Result/Provisional Merit List of the Common Entrance Test for admission to GNM Lateral Entry (L.E) Course-2024 vide Notification No. 036-BOPEE of 2024 dated 26-06-2024, it is hereby notified for all the concerned candidates that the Board shall conduct the 1st Round of Physical Counseling for admission to GNM Lateral Entry (L.E) Course-2024 w.e.f. **05-08-2024 to 07-08-2024** as per the following schedule:

All the eligible/interested candidates are advised to report physically at BOPEE Office Jammu/Srinagar on the above dates between 08.30 a.m. to 10.00 a.m. for attendance and registration along with the following documents in original:

- Domicile Certificate;
- FMPHW/MMPHW/ANM Diploma/Marks Cards of both years;
- Valid Category Certificate, if applicable;
- Date of Birth Certificate (Diploma/10th Class Marks Card)

All the participating candidates shall deposit the Counseling fee of **Rs.1000/- (Rupees one thousand only)** through the POS Machines available at the BOPEE office Jammu/Srinagar through Debit/Credit cards. Any candidate who fails to deposit the counseling fee shall not be allowed to participate in the counseling process.

Further, if any, candidate is not able to participate personally in the counseling on designated day & date of Counseling due to unavoidable circumstances, he/she can authorize his/her close family member who falls in his/her blood relation on the devised format of the Board to participate in the counseling on behalf of the concerned candidate. The said authorized person had to submit the authorization letter along with his Identity Card and

Aadhar Card during the process of counseling otherwise he/she shall not be allowed to participate in the counseling on their own risk and responsibility.

A candidate who fails to participate in his counselling on a particular (designated) date, shall, however, be allowed by the Board to participate in the counselling process on the next day; provided that he/she **does not claim any stake** on a seat which was available on his/her date of counseling but has already been allotted to a candidate figuring next in the order of merit list, on the grounds that the concerned candidate could not participate in the physical round of counselling earlier when the seat was available.

Seat matrix shall be uploaded separately on the official website of the Board within due course of time before counselling and all the participating/eligible candidates are advised to go through seat matrix before participating in the counselling process.

The Board shall stop the counseling process immediately as and when the seats are fully exhausted.

The other terms and conditions shall remain the same as notified by the Board through the various Notifications/Notices issued from time to time in this regard.'
