Consequent upon the declaration of the Result/Provisional Merit List of the Common Entrance Test for admission to M.Sc. Nursing Course-2024 vide Notification No. 058-BOPEE of 2024 dated 27-07-2024, it is hereby notified for all the concerned candidates that the Board shall conduct the 1st Round of Physical Counselling for admission to M.Sc. Nursing Course-2024 of only those candidates who have secured upto 50 marks out of 120 marks in the Common Entrance Test i.e. upto Rank 245 of Provisional Merit List. As such the candidates upto the Rank 245 are hereby advised to report for participation in the counselling process on 22 -08-2024 as per the following schedule:

All the eligible/interested candidates are advised to report physically at BOPEE Office Jammu/Srinagar on the above date between 08.30 a.m. to 10.00 a.m. for attendance and registration along with the following documents in original:

- I. Domicile Certificate;
- II. B.Sc. Nursing / Post Basic B.Sc. Nursing/ B.Sc. Hons. Nursing Marks Card;
- III. One Year work experience after B.Sc. Nursing/Post Basic B.Sc. Nursing;
- IV. Certificate as a registered Nurse or Registered Midwifery or equivalent with any state Nursing Council;
- V. Valid Category Certificate, if applicable;

All the participating candidates shall deposit the Counselling fee of **Rs.1000/-(Rupees one thousand only)** through the POS Machines available at the BOPEE office Jammu/Srinagar through Debit/Credit cards. Any candidate who fails to deposit the counselling fee shall not be allowed to participate in the counselling process.

Further, if any, candidate is not able to participate personally in the counselling on designated day & date of Counselling due to unavoidable circumstances, he/she can authorize his/her close family member who falls in his/her blood relation on the devised format of the Board to participate in the counselling on behalf of the concerned candidate on his/her own risk and responsibility. The said authorized person had to submit the authorization letter along with his Identity Card and Aadhar Card during the process of counselling otherwise

he/she shall not be allowed to participate in the counselling on their own risk and responsibility. Further, the OBC & EWS certificates should be as per UT performa.

It is further enjoined upon all the concerned candidates to ensure the validity of the Category Certificate, which in any case should not have been issued after **15.06.2024** i.e. the last date fixed by the Board for filling up of online application forms for M.Sc. Nursing Courses, 2024 vide Notification No. 027-BOPEE of 2024 dated 15.06.2024.

The seats shall be allotted to the candidates as per S.O. 176 dated 15-03-2024 read with S.O. 305 dated 31-05-2024 issued by Social Welfare Department, UT of J&K.

Seat matrix shall be uploaded separately on the official website of the Board within due course of time before counselling and all the participating/eligible candidates are advised to go through seat matrix before participating in the counselling process.

The Board shall stop the counselling process immediately as and when the seats are fully exhausted.

The other terms and conditions shall remain the same as notified by the Board through the various Notifications/Notices issued from time to time in this regard.'
