- 6. ID Proof.
- 7. Two Passport Size Photographs.
- 8. Preference of Colleges (Lady Hardinge Medical College New Delhi is meant forfemales only).
- 9. Certificates/ Documents from the Competent Authorities as detailed in the above table.

The last date for submission of applications with full details/ documents shall be upto 28.08.2024 (till.3.00pm), no application shall be entertained after the cutoff date.

- 1. Mere submission of documents/applications by the candidates shall not confer any right on the candidate to claim the seat, which shall be decided by the appropriate authorities of the Government in accordance with the merit/eligibility criteria prescribed by the concerned authorities.
- 2. The selection of eligible candidates will be made as per guidelines issued under Office Memorandum No. U. 14014/16/2022-ME-II dated 12.08.2024 of Ministry of Health & Family Welfare, Government of India, New Delhi.
