**Subject: - Online Registration of NEET UG – 2024 candidates belonging to UT of J&K/ Ladakh.**

Reference: - Notification No. 068-BOPEE of 2024 dated 09-08-2024.

## **Notification No:078-BOPEE of 2024 Dated:18-08-2024**

Consequent upon the declaration of the NEET UG- 2024 re-revised result by the National Testing Agency (NTA) on 26th July, 2024 and subsequently notified by the Board vide Notification No. 068-BOPEE of 2024 dated 09.08.2024, the candidates belonging to the UT of J&K / Ladakh who have qualified the NEET-UG 2024 having scored the cut-off marks prescribed by the NTA and whose names figure in **Annexure-A** of the above referred notification and also the candidates whose names were not available in the said annexure but are the domiciles of J&K/ Ladakh and have submitted their documents in response to the aforementioned notification under reference forming **Annexure -A** to this Notification are hereby informed through the medium of this Notification to register themselves and upload the following documents online w.e.f **19-08-2024 to 23-08-2024 (mid-night)** so that Provisional UT Merit List (PUTML) of such eligible candidates belonging to UT of J&K/ Ladakh is prepared:-

1. NEET-UG score card - 2024.
  2. 10+2 Marks Card.
  3. Domicile Certificate of UT of J&K / Ladakh (ST Category certificate in respect of candidates belonging to the UT of Ladakh).
  4. \*Category Certificate, wherever required.
  5. Date of Birth Certificate (Matriculation).
  6. The candidates belonging to the UT of Ladakh are required to upload Compulsory Service Bond (which shall be available in the Information Brochure to be uploaded by the Board on the official website ([www.jkbopee.gov.in](http://www.jkbopee.gov.in))).
- \* OBC & EWS category certificates shall be as per the performa prescribed for UT of J&K.

The cut off score for different categories is as under:

a. Open Merit (including JKPM/CDP/Sports/EWS)	: 162
b. Open Merit/EWS & PwD	: 144
c. SC/ST1/STII/OBC/ALC/IB/RBA	: 127
d. SC/ST1/STII/OBC/RBA/ALC/IB & PwD/ JKPM/Sports/CDP	: 127

### **NOTE:**

1. The candidates are advised not to use Mobile Phones for Registration purposes / uploading of documents.
2. The e-Information Brochure for NEET UG-2024 Courses has been uploaded by the BOPEE on its website ([www.jkbopee.gov.in](http://www.jkbopee.gov.in)). The candidates are accordingly advised to go through the e- Information Brochure before registration.
3. **No under process certificates shall be entertained.**

4. **The category certificates issued only up to the last date of registration shall be entertained.**
5. The candidate must fulfill all other criteria as laid down in the NEET-UG 2024 Information Brochure of NTA and Information Brochure of J&K BOPEE in respect of NEET UG- 2024 courses.
6. Any candidate found ineligible at any point of time shall not be allowed to participate in the counseling process notwithstanding the registration/NEET qualifying score.
7. The candidates should enter their valid e-mail address/mobile numbers as all important communications shall be made with them on such e-mails/mobile numbers provided by them, whenever required by the Board.
8. Candidates, in their own interest, are advised not to share their e-mail password with other candidates/persons.
9. Board shall not be responsible for any mistake committed by the candidates, while making the registration.
10. After completion of the registration process, Board shall notify the Provisional UT Merit List (PUTML) of all the candidates, which shall be used for online counseling by the candidates (filling up of the preferences) based on which allotment of seat shall be made.
11. Any candidate, who falls within the qualifying merit but does not register himself/herself or does not upload the documents or the documents uploaded are deficient shall not be considered for allotment of any seat.
12. The candidates, in their own interest, are advised to go through the e-Information Brochure as and when uploaded by Board on its website viz. [www.jkbopee.gov.in](http://www.jkbopee.gov.in) and go through the technical and other instructions before registering themselves.
13. Since the admission in the Professional Colleges is time bound, the candidates should not wait for last date of registration as it may be detrimental to the interest of the candidate(s).
14. The candidates, who intend to participate against NRI/HM Quota seats in ASCOMS, Jammu shall also have to register themselves online in pursuance to this notification otherwise they are not eligible for counselling under NRI/HM quota. However, they shall have to submit all such documents offline also separately in the Board office at Jammu/Srinagar up to the date as may be notified by the Board separately.
15. Candidates are advised to remain in touch with the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) and should not wait for publication of Notices/Notifications in the News Papers, which may get delayed for the reasons beyond the control of the BOPEE.
16. Mere submission of Application Form(s) and Registration of candidates shall not confer any right on all such candidates for admission, but shall be subjected to the fulfilment of the eligibility criteria and the qualification prescribed for the said course(s) after verification of their documents at the time of admission in the College/ Institution of provisionally selected candidates.
