Subject: Allocation of MBBS Seats from Central Pool for spouse and children of Civilian Victims of Terrorism for the academic year 2024-25.

Notification No: 092-BOPEE of 2024. Dated: 01-09-2024

Pursuant to Communication No.17015/49/2024-CT-II dated 23.08.2024 from Ministry of Home Affairs, Government of India, Offline Applications are invited from eligible candidates on prescribed format annexed as **Annexure-A** to this Notification for allocation of four (4) MBBS Seats from the Central Pool for Spouse and Children of Civilian Victims of Terrorism for the academic year 2024-25. The eligibility is briefly reproduced as under:

Eligibility Conditions:

- i. Candidate must either be spouse or children of the deceased/disabled civilian victim of terrorism.
- ii. He/she has completed 17 years of age at the time of admission or will complete the age on or before 31st December of the year of his/her admission to the first year of the Undergraduate Medical Course and is an Indian National.

iii. Educational Qualification:

As per Graduate Medical Education Regulation of National Medical Commission, the candidate must have passed in the subjects of Physics, Chemistry, Biology /Bio-Technology and English individually and must have obtained a minimum of 50% marks (40% for SC/ST-i/ST-ii/OBC//ALC/IB/RBA & 45% for General PH and 40% for SC-PwD/ST-i-PwD/ST-ii-PwD/OBC-PwD/ALC/IB-PwD/RBA-PwD category candidates) taken together in Physics, Chemistry, Biology/Bio-Technology at the qualifying examination of 12th Class.

iv. Qualifying percentile in NEET (UG)-2024:

The selection of candidates will be made on the basis of rank obtained in the National Eligibility-cum-Entrance Test (NEET) -2024 being conducted by the National Testing Agency (NTA). As per Graduate Medical Education Regulations of National Medical Commission, it shall be necessary for the candidates to obtain minimum marks at 50th percentile at NEET(UG)- 2024. However, in respect of candidates belonging to SC/ST-i/ST-ii/OBC/ALC/IB/RBA, the minimum marks shall be at 40th percentile. In respect of candidates with special disabilities, the minimum marks shall be at 45th percentile. The percentile shall be determined on the basis of highest marks scored in the All-India Common Merit List in National Eligibility-cum-Entrance Test for admission to MBBS/BDS Courses.

Reservation:

The Reservation Policy being followed by the UT of J&K shall apply on Central Pool MBBS Seats:

The Documents required to be attached are as under:

- 1. Domicile Certificate of UT of J&K.
- 2. NEET- Score Card.
- 3. 10+2 Marks Card 2024.
- 4. Date of Birth Certificate.
- 5. Category Certificate, if any.

In addition, the applicants shall have to submit the following documents priority wise duly authenticated by the Home Department of J&K Government for ascertaining the eligibility under victim **priority-I, II & III**:

- (ii) (a) Subject to the fulfillment of eligibility criteria as laid down by in para (2) of the above referred communication, all the candidates in Priority-I category would be allotted available seats on the basis of rank obtained in NEET UG-2024 conducted by NTA.
 - (b) If any seats are still available after covering all eligible candidates in Priority-I category, candidates in Priority-II would be allotted the available seats on the basis of the rank obtained in NEET UG-2024.
 - (c) After allotting seats to all eligible candidates in Priority-I and then in Priority-II category, the balance available seats would be allotted to the candidates in Priority-III category on the basis of rank obtained in NEET UG 2024
 - (d) The benefits against Priority-I or Priority-II would be restricted only to one ward of the civilian victims of terrorists. If this benefit has already been availed of in respect of one ward, then the second ward would not be eligible to be considered against these reserved seats.

Further, the Board undertakes that mere submission of applications shall not confer any right on the applicant for his/her selection, which shall be done by the Ministry of Home Affairs Government, of India, in accordance with the rules/ procedures on the subject.

Note.

- (I) The Ministry of Home Affairs, Government of India is not conducting any examination in this regard, the selection will be made by the said Ministry on the basis of marks obtained by the students/applicants in NEET-UG 2024 and possessing necessary educational qualification as defined hereinabove.
- (II) The last date of submission of application (s) in duplicate is 06.09.2024 (till 3:00 pm). The application(s) shall be submitted/ deposited by the eligible candidates at J&K BOPEE offices Jammu/Srinagar physically upto the prescribed date and time.
