- That the Candidate having highest merit in NEET-UG, 2024 will be recommended.
- That the Candidates shall be the Domicile of J&K.
- The roster for Professional Degree Courses will be followed strictly as per the instructions/notifications of the Social Welfare Department. As the recommendation is being made for the first time, so the Roster point No. 01 is to be utilized. Hence the seat will be Open Category (OM) seat.
