Consequent upon the conclusion of all the rounds of counseling for admission to B.Ed. Courses-2024 and after receiving the shortfall from all the Institutes/Colleges vide Notification No. 087-BOPEE of 2024 dated 29-08-2024, number of seats in various colleges remain unfilled. In order to fill up all those seats, it is hereby notified for the information of all the concerned candidates that the Board is inviting the fresh applications from all the eligible candidates for admission/upgradation to B.Ed. Course-2024 in Institute of Advanced Studies in Education (IASE), Srinagar /B.Ed. Special Education in Composite Regional Centre (CRC), Srinagar/Government College of Education, Jammu w.e.f 27-09-2024 to 02-10-2024. in offline mode as per the prescribed form annexed as **Annexure A** to this Notification.

Eligibility:

- Candidates with at least 50% marks either in the Bachelor's Degree and or in the i) Master's Degree in Sciences/Social Sciences/Humanity, Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme & 5% relaxation for SC/ST-i/ST-ii/RBA/ALC/IB/OBC and those candidates who had already registered and appeared in CET conducted by BOPEE on 14-04-2024 are also eligible for upgradation/admission.
- ii) Should be a Domicile of UT of J&K/UT of Ladakh.

Important Information:

- 1. The candidates applying for the 1st time shall have to deposit the application fees of Rs 1000/- through POS Machine available at BOPEE Offices Jammu/Srinagar using their Debit/Credit Card.
- 2. The candidates, in their own interest, are advised to go through the e-Information Brochure before applying. The Board shall not be responsible for any act of omission or commission in filling up of the Offline Application Form by the candidate. It shall be presumed that the candidate has gone through the information contained in the Information Brochure and has agreed to follow the conditions contained therein.
- 3. The procedure for upgradation/allotment of seats to be followed is mentioned as below:
 - a) Upgradation/allotment of seats for already admitted candidates shall be made on the basis of CET 2024 score first.
 - And subsequently as per merit of qualifying examination marks for the fresh candidates.

- 4. The candidates are further advised to remain in touch with the BOPEE website www.jkbopee.gov.in.
- 5. The availability of seats in different Institutes/Colleges shall be reflected in the Seat Matrix in due course of time.
- 6. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.
- 7. The other terms and conditions shall however remain the same as notified by the Board through various Notifications/Notices and e-Information Brochure in this regard.
