Consequent upon the declaration of the Result/PML vide Notification No. 070-BOPEE of 2024 dated 14-08-2024, it is hereby notified for information of all the eligible candidates that the Board shall conduct the 1st round of counselling (Physical) for admission to the 10th Based Paramedical Diploma Courses-2024 in various Government/Private Colleges/Institutions of UT of J&K/Ladakh simultaneously at BOPEE office Jammu/Srinagar seat(s) as per the following schedule:

Note:

1. The concerned candidates shall have to report at the BOPEE offices Jammu/Srinagar Physically for Registration/Attendance and fulfillment of other formalities between 8:30 a.m. to 10:00 a.m. rank wise on the dates of their counselling as mentioned above.
2. The participating candidates shall have to deposit the Counselling fee for **Rs. 1000/- (Rupees one thousand only)** through the POS Machines available at the BOPEE office Jammu / Srinagar through Debit /Credit Cards. Any candidate who fails to deposit the counselling fee shall not be allowed to participate in the counselling process
3. The candidates are advised to bring along their Domicile Certificate issued by the competent authority and other relevant documents/certificates as applicable to be presented at the time of counselling.

4. The allotment of seat(s) (Discipline/Institution) shall be made in pursuance of S.O. 176 Dated 15.03.2024 read with S.O. 305 (21-05-2024) to the eligible candidates where ever applicable.
5. The candidate who fails to attend the counselling on a particular (designated) day shall be allowed by the Board to participate in the counselling on the next day provided he/she does not stake any claim on a seat which has already been allotted to a candidate next in merit (to such candidate) on the ground that the candidate could not participate in the physical round of counselling earlier when the seat was available.
6. The candidates who have failed to submit their deficient Category Certificate within the prescribed time limit mentioned in **Notification No. 070-BOPEE of 2024 Dated: 14-08-2024** shall be converted into Open Merit, if otherwise, eligible in the said category.
7. Any candidate who may not be able to attend counselling physically owing to a valid reason can authorize a person (through Authority Letter-on prescribed format) from his/her family member to participate in the counselling on his/her behalf at BOPEE offices Jammu/Srinagar on day/date of counselling as per his/her Rank.
8. The Board shall notify the Provisional Selection list of the candidates indicating Application Number, Name, Gender, Category, Name of Institution and Discipline after conclusion of the counselling.
9. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.
10. The candidates are advised to remain in touch with BOPEE website (www.jkbopee.gov.in) daily during the days of counselling for latest updates of seat matrix.

The candidates provisionally selected for these Diploma Paramedical courses are advised to contact the concerned college/institution for their fee structure and other requisite formalities / documents.
