Subject: Admission to MBBS/BDS/DDM/DDH Courses-2024 along with OM/HM/NRI Quota seats in ASCOMS Jammu: Conduct of 3rd /Mop-up round thereof.

Reference: Notification No. 109-BOPEE of 2024 dated 15.09.2024.

Notification No. 136-BOPEE of 2024 Dated 15-10-2024

Pursuant to Notification No. 109-BOPEE of 2024 dated 15.09.2024, the Board has received shortfall of seats in MBBS/BDS/DDM/DDH Courses from various Government/Private Medical/Dental Colleges of UT of J&K. In order to fill up these seats along with the seats which have remained unfilled or which have become available due to the withdrawal of admission by some selected candidates from the respective allotted college(s) and the seats of ASCOMS under OM/Hindu Minority (HM) / Non Resident Indians (NRI) Quota, it is hereby notified for information of all the concerned candidates that the Board shall conduct the 3rd/Mop Round of (Physical) Upgradation/Allotment counseling as per the schedule given below: -

It is further notified that the candidates may go through the following conditions carefully in order to determine their eligibility in this third/mop-up round of counselling: -

- The candidates who have not been allotted any seat during the 1st / 2nd round of counseling shall be eligible to participate in the 3rd /mop-up round in terms of conditions contained in the e-Information Brochure.
- 2. The candidates who have been allotted a seat during the 1st round of counseling and have joined the college but have not been upgraded during the 2nd round owing to less merit are allowed to participate in the mop-up round. Those candidate(s) who have been allotted seat during the 2nd round of counseling and have joined the College/Institution and want to participate in the third/ mop-up round for purpose of up-gradation are also eligible to participate in the mop-up round. Further any candidate who has been allotted a seat during First round of counseling but has not joined against the allotted seat/college shall also eligible for 3rd /Mop up round. However, any candidate upgraded during the 2nd round of counseling shall under no circumstances be

- **eligible to participate in the 3rd/mop-up round**. Further any candidate who has been allotted a seat during Second round of counseling but has not joined against the allotted seat/college shall also not be eligible for 3rd / Mop up round.
- 3. The candidates who have been allotted seat(s) in AIQ 3rd round and have joined the respective allotted College / Institution shall not be eligible to participate in this mop-up round.
- 4. The candidates who will be upgraded/allotted seats during the 3rd /mop-up round shall have to mandatorily join the College/Institution upto the last date of joining as shall be fixed by the Board.
- 5. The candidates participating **first** time shall have to pay the **counseling fee of Rs 1500/-** through POS machine available at BOPEE office Jammu/Srinagar using their Debit/Credit Card.
- The candidates should go through all the relevant Notifications / Notices along with the e-Information Brochure notified by the Board with particular reference to the mop-up round of counseling.
- 7. The Board shall firstly conduct the counseling of Horizontal and Reserved Category candidates on **18.10.2024** and if any reserved category seat(s) remains unfilled due to non-availability of eligible candidates, then those seats shall be converted into O.M. in terms of Section 9(2) of J&K Reservation Act, 2004 and shall be filled up accordingly as per merit.
- 8. The category candidate(s), who may not get a seat in his/her category shall be eligible to participate in the counseling as an O.M. candidate as per his/her merit subject to the condition that he / she falls within the cut off score of O.M. fixed by the NTA.
- 9. The tentative details of seats to be filled during 3rd/mop-up round of counselling shall be uploaded on website of the Board viz. www.jkbopee.gov.in one day before the date of counselling to facilitate the candidates to decide to report for counselling.
- 10. The seats available in DDH and DDM in Government Dental College Jammu and Srinagar shall be filled on the basis of merit cum preference and not on the basis of gender.
- 11. The candidate(s) participating in this physical round of counselling and getting allotted a seat, should in their own interest not leave the Board office as there may be a possibility that a seat of his/her choice, which was not available on his/her turn of counselling may become available during the process, he/ she can stake a claim on such a seat immediately once the seat is displayed in the seat matrix on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis. The seat allotted to him/her earlier shall become vacant and be added to the seat matrix. The Board shall not be responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as discussed above.
- 12. All the willing/eligible candidates are advised to check the seat matrix to be uploaded by the J&K BOPEE on its official website a day before start of the 3rd/Mop Up Round of Counseling and in case the seat(s) of their choice are available, only then they should participate in the 3rd/Mop Up round of counseling.
- 13. The counseling will be automatically stopped as and when the seats will be filled and no claim(s) from the waiting candidates, if any, shall be entertained by the Board.

The other Terms and Conditions shall, however, remain the same as contained in the e-Information Brochure, Notifications and Notices issued by the Board from time to time in this regard.
