Subject: Conduct of 2nd Round of Upgradation/Allotment counselling (physical) for admission to BAMS/BUMS/BPT Courses 2024 in Government/Private Colleges/Institutions of UT of J&K.

## Notification No. 140-BOPEE of 2024 Dated 17-10-2024

Pursuant to Notification No. 114-BOPEE of 2024 dated 19.09.2024 the physical counselling for filling up of seats of Ayush courses-2024 was conducted by the Board. The provisional selection list of candidates was notified vide Notification No. 122-BOPEE of 2024 dated 27.09.2024 and the candidates were advised to report to the respective Colleges/Institutions upto 04.10.2024. Consequent upon the shortfall received from the Government/Private Colleges/Institutions running AYUSH Courses (BAMS/BUMS) & BPT-2024 and the seats that have remained vacant after the conclusion of the 1<sup>st</sup> Round of physical Counselling, it is hereby notified for information of all the concerned candidates that the Board shall conduct the 2<sup>nd</sup> Round of Upgradation/Allotment counselling (Physical) for admission to these courses in Government/Private Colleges/Institutions of UT of J&K on 21<sup>st</sup> and 22<sup>nd</sup> of October 2024 at BOPEE office Srinagar/Jammu simultaneously as per the following schedule:

## Note:

- 1. The eligible and willing candidates shall have to report at the BOPEE offices Jammu/Srinagar for Registration/Attendance and fulfillment of other formalities, from 08:30 a.m. to 10:00 a.m. on the day/date of counseling.
- 2. It is enjoined upon all the eligible candidates that they shall attend counseling only after checking the Seat Matrix.
- 3. The candidate(s), if any, who miss his/her counseling on the first day of the counseling, he/she shall be allowed to participate in the counselling on the 2<sup>nd</sup> day subject to the condition that he/she shall not claim for the seat which otherwise was available on his/her actual turn of counselling.
- 4. The candidates are advised to bring along their valid Domicile Certificate issued by the competent authority and also other relevant certificates/documents as applicable to be presented at the time of counselling.
- 5. The candidate(s) who has/have been allotted seat/college during 1<sup>st</sup> round of counselling but failed to join against the said seat/college, he/she shall not be eligible to participate in the 2<sup>nd</sup> round of counselling under any circumstances.

- 6. Those candidates who have remained absent or got CNA/SNA during first round of Counselling are also eligible to participate in this round of Counselling.
- 7. Those candidate(s) who have been allotted seat(s) during the First Round of Counseling and have joined against the said seat/College, if interested for upgradation are also eligible to participate in the 2<sup>nd</sup> Round of Physical Counseling with the condition that they shall have to produce their fee deposition receipt of the concerned allotted College at the time of their admission in that College.
- 8. The candidates who are participating for the first time in the Counseling process are advised to deposit an amount of **Rs.1500/** as a counseling fee on the day of Counselling through POS Machines available at BOPEE office Jammu/Srinagar through Debit/Credit card.
- 9. The candidates belonging to the CDP category are advised to bring along the valid CDP priority certificate issued by the competent authority on the day of counselling.
- 10. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.
- 11. As already mentioned in the Notification No. 114-BOPEE of 2024 dated 19.09.2024, the seats under AIQ (All India Quota) & MQ (Management Quota) seats shall be filled up during 2<sup>nd</sup> round of counseling on the basis of NEET score. Five candidates from AIQ have applied under this quota seats till last date fixed by the Board i.e., 28-09-2024 as per Notification No. 118-BOPEE of 2024 dated 26-09-2024. In case AIQ seats are not filled by the candidates who have applied under this quota, such seats shall be converted into UT quota & allotted to the candidates belonging to UT of J&K purely on the basis of the NEET merit cum preferences filled by the candidates in this round of counseling process.
- 12. The Seat Matrix for 2<sup>nd</sup> Round of upgradation/allotment counselling shall be uploaded on the website of the Board for information of the candidates in due course of time.
- 13. This notification is issued without any prejudice and subject to final outcome of the writ petition if any, pending before any competent court of law

The other terms & conditions shall, however, remain the same as notified by the Board in various Notifications/Notices issued from time to time in this regard.
