All the eligible/interested candidates are advised to report physically at BOPEE Office Jammu/Srinagar on the above date between 08.30 a.m. to 10.00 a.m. for attendance and registration.

The candidates are advised to bring along all the original documents/certificates including Domicile Certificate/Category Certificate, if any, issued by the Competent Authority which shall be presented by them at the time of Counselling for scrutinization and verification by the Board.

All the participating candidates shall deposit the Counselling fee of Rs.1000/- (Rupees one thousand only) through the POS Machines available at the BOPEE office Jammu/Srinagar through Debit/Credit cards. Any candidate who fails to deposit the counselling fee shall not be allowed to participate in the counselling process.

Mere figuring in the Provisionally Merit List shall not confer any right on the participating candidates to claim any seat unless his/her eligibility shall be verified by the subject experts from SKIMS present on the day of counselling.

The Board reserves the right to make any change(s) as may become necessary in view of any technical difficulties or the reasons beyond its control.

The course-wise eligibility shall be verified during the counselling by the Experts from SKIMS Soura, Srinagar.

As and when the seats are exhausted the counselling process shall automatically be closed and no further claim regarding refund of counselling fee and allotment of seat(s) shall be entertained by the Board under any circumstances.

The seat matrix shall be uploaded on the website of the Board separately before the day of counselling.
