- 2 Horizontal Reservation in Govt. Institutions:

As notified and explained vide at S.No. 2 Rule 4 (Explanation B) in S.O. 127 Dated 20-04-2020 issued by Social Welfare Department Govt. of J&K, horizontal reservation means the reservations which would cut across the vertical reservation (What is called interlocking reservation) and the person selected against the horizontal reservation quota will have to be placed in the appropriate category viz. if he/she belongs to the scheduled caste category, he/she shall be placed in that quota by making necessary adjustment and similarly if he/she belongs to the open competition Category, he/she will be placed in that category.

- a) 4% of the Total Seats to PwD (Persons with disabilities) with idendified benchmark disabilities as identified by the Govt..
- b) 3% of the Total Seats to CDP (Childeren of Defence Personnel).
