It is hereby notified for the information of all the concerned candidates that the National Commission for Indian System of Medicine, Ministry of Ayush, Government of India vide Letter No. NCISM/Examination/StateDME/2024 dated 12-11-2024 has lowered the qualifying percentile for admission in UG Courses of ASU by **Fifteen percentile across all categories** for the academic year 2024-25.

The candidates who fall within the ambit of said revised percentile score and are willing to participate in the subsequent round of counseling against the seats that have remained unfilled during previous rounds of counseling are advised to apply afresh as per Annexure-A to this Notification and submit all the requisite documents as mentioned in Notification No. 095-BOPEE of 2024 Dated: 04-09-2024 physically at BOPEE office Jammu/Srinagar w.e.f 21-11-2024 to 23-11-2024. The candidates who are eligible and have not registered earlier and does not figure in the UT Merit list of 2024 annexed to the Notification No. 110-BOPEE of 2024 dated 16-09-2024 but wants to be considered himself/herself against the unfilled seat/seats may also submit their documents physically at BOPEE office Jammu/Srinagar for registration within the prescribed time schedule indicated here in above.
