It is hereby notified for the information of eligible candidates of NEET PG-2024 whose names are figuring in the Provisional Merit List (PML) issued by the Board vide Notification No. 167-BOPEE of 2024 dated 18-11-2024 and who are interested for admission in MD/MS Courses 2024 in ASCOMS – Jammu under Hindu Minority and NRI Quota to submit their relevant documents on the prescribed proforma at the BOPEE Offices Srinagar/Jammu w.e.f. **26th November, 2024 to 2nd December, 2024 (till 03:00 P.M)**. The details of the seats are given herein under:

- B. The NRI / Hindu Minority Quota seats for MD/MS in ASCOMS shall be filled up separately through a process of Physical/Online counselling, the schedule for which shall be notified separately by the Board.**

Important Note:

- I. The last date for submission of the documents under NRI/Hindu Minority Quota physically at BOPEE office Jammu/Srinagar is: 02-12-2024 (till 03:00 P.M).
- II. The check list Proformas for Hindu Minority (HM) / NRI is available as **Annexure-A & B** to this Notification only on the official website of BOPEE i.e. www.jkbopee.gov.in only.

General Conditions: - The candidates applying for NRI/HM Quota seats;

1. should have applied under NEET PG-2024 and have qualified /obtained minimum qualifying percentile score as an eligibility condition and
2. should also have uploaded other documents except HM/NRI certifications during registration process on BOPEE website in response to the Notification No. 121-BOPEE of 2024 dated 27- 09-2024.

Fee Structure: -

The fee is fixed by the Government of J&K for MD/MS seats in ASCOMS vide Government Order No. 659-HME of 2019 dated 10-07-2019 read with Government order no. 221-HME of 2016 dated 01-04-2016, &

eligible candidates are advised to confirm fee from respective College before submitting the documents at BOPEE office Jammu/Srinagar.

Eligibility of NRI Seats: -

Category No. 1: - Whereas an applicant himself /herself is NRI and family originally belongs to the UT of J&K.

Category No. 2: - Children/wards of NRI, who originally belongs to the UT of J&K.

Further, the documents required for NRI Category 1 and 2 are as under: -

Category No. 1:

- i. NEET PG-2024 Score Card;
- ii. NRI certificate issued by the Ministry of External Affairs, Government of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport;
- iii. Copy of NRI Bank Account preferably in the country where the candidate is residing or of NRI Account in India;
- iv. Copy of Indian Passport;
- v. Copy of Income Tax Return filed in India, if any;
- vi. PAN Card, if any;
- vii. Domicile Certificate of the candidate.
- viii. Any other document as may be required by the Board for its satisfaction

Category No. 2:

- i. NEET PG-2024 Score Card;
- ii. NRI Sponsorship Letter;
- iii. Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian Embassy Overseas;
- iv. Bank Statement of the Sponsor;
- v. Resident/National Certificate or NRI certificate of the sponsor;
- vi. Pedigree Table/Family Tree establishing relationship of the candidate with the sponsor along with documentary Proof;
- vii. Employment certificate of the sponsor;
- viii. PAN Card, if any of the sponsor;
- ix. PAN Card, if any of the candidate/parents;
- x. Copy of Income Tax Return filed, if any;
- xi. Domicile Certificate of the candidate.

The prescribed Proformas as **Annexure-A & B** to this Notification are available only on the official website www.jkbopee.gov.in of the board.

Note: -

1. The seats shall be filled up purely on the basis of Eligibility and Merit of the candidates secured in the NEET-PG 2024 and as per JKUT Specific Provisional Merit List.
2. **Only such candidates shall be eligible, who have registered themselves online and figured in the JKUT Specific Provisional Merit List as notified by the Board vide Notification No. 167-BOPEE of 2024 dated 18-11-2024.**

3. The candidate applying under Hindu Minority Quota shall be required to produce a certificate from the Competent Authority that he/she belongs to the Hindu Minority (HM) Community.
4. Only Domiciles of UT of J&K are eligible to compete against the above seats of HM and NRI.
5. The eligibility under NRI shall be subjected to such other conditions as may be notified by the Competent Regulatory Body of the Government of India / UT Government or such orders of the Hon'ble Supreme Court applicable on the subject.
6. Mere submission of the documents does not confer any right of candidate for admission unless and until the eligibility is verified by the board.
