It is hereby notified for the information of eligible candidates of NEET PG-2024 whose names are figuring in the Provisional Merit List (PML) issued by the Board vide Notification No. 167-BOPEE of 2024 dated 18-11-2024 and who are interested for admission in MD/MS Courses 2024 in ASCOMS – Jammu under Hindu Minority and NRI Quota to submit their relevant documents on the prescribed proforma at the BOPEE Offices Srinagar/Jammu w.e.f. **26th November, 2024 to 2nd December, 2024 (till 03:00 P.M).** The details of the seats are given herein under:

B. The NRI / Hindu Minority Quota seats for MD/MS in ASCOMS shall be filled up separately through a process of Physical/Online counselling, the schedule for which shall be notified separately by the Board.

Important Note:

- I. The last date for submission of the documents under NRI/Hindu Minority Quota physically at BOPEE office Jammu/Srinagar is: 02-12-2024 (till 03:00 P.M).
- II. The check list Proformas for Hindu Minority (HM) / NRI is available as **Annexure-A & B** to this Notification only on the official website of BOPEE i.e.www.jkbopee.gov.in only.

General Conditions: - The candidates applying for NRI/HM Quota seats;

- should have applied under NEET PG-2024 and have qualified /obtained minimum qualifying percentile score as an eligibility condition and
- 2. should also have uploaded other documents except HM/NRI certifications during registration process on BOPEE website in response to the Notification No. 121-BOPEE of 2024 dated 27- 09-2024.

Fee Structure: -

The fee is fixed by the Government of J&K for MD/MS seats in ASCOMS vide Government Order No. 659-HME of 2019 dated 10-07-2019 read with Government order no. 221-HME of 2016 dated 01-04-2016, &

eligible candidates are advised to confirm fee from respective College before submitting the documents at BOPEE office Jammu/Srinagar.

Eligibility of NRI Seats: -

Category No. 1: - Whereas an applicant himself /herself is NRI and family originally belongs to the UT of J&K.

Category No. 2: - Children/wards of NRI, who originally belongs to the UT of J&K.

Further, the documents required for NRI Category 1 and 2 are as under: -

- ii. NRI certificate issued by the Ministry of External Affairs, Government of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport;
- iii. Copy of NRI Bank Account preferably in the country where the candidate is residing or of NRI Account in India;
- iv. Copy of Indian Passport;
- v. Copy of Income Tax Return filed in India, if any;
- vi. PAN Card, if any;
- vii. Domicile Certificate of the candidate.
- viii. Any other document as may be required by the Board for its satisfaction

Category No. 2:

- i. NEET PG-2024 Score Card;
- ii. NRI Sponsorship Letter;
- iii. Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian Embassy Overseas;
- iv. Bank Statement of the Sponsor;
- v. Resident/National Certificate or NRI certificate of the sponsor;
- vi. Pedigree Table/Family Tree establishing relationship of the candidate with the sponsor along with documentary Proof;
- vii. Employment certificate of the sponsor;
- viii. PAN Card, if any of the sponsor;
- ix. PAN Card, if any of the candidate/parents;
- x. Copy of Income Tax Return filed, if any;
- xi. Domicile Certificate of the candidate.

The prescribed Proformas as **Annexure-A & B** to this Notification are available only on the official website www.jkbopee.gov.in of the board.

Note: -

- 1. The seats shall be filled up purely on the basis of Eligibility and Merit of the candidates secured in the NEET-PG 2024 and as per JKUT Specific Provisional Merit List.
- 2. Only such candidates shall be eligible, who have registered themselves online and figured in the JKUT Specific Provisional Merit List as notified by the Board vide Notification No. 167-BOPEE of 2024 dated 18-11-2024.

- 3. The candidate applying under Hindu Minority Quota shall be required to produce a certificate from the Competent Authority that he/she belongs to the Hindu Minority (HM) Community.
- 4. Only Domiciles of UT of J&K are eligible to compete against the above seats of HM and NRI.
- 5. The eligibility under NRI shall be subjected to such other conditions as may be notified by the Competent Regulatory Body of the Government of India / UT Government or such orders of the Hon'ble Supreme Court applicable on the subject.
- 6. Mere submission of the documents does not confer any right of candidate for admission unless and until the eligibility is verified by the board.
