- The admission of candidate will be purely provisional and liable to be cancelled in case any information furnished by any candidate(s) proves to be false / fabricated and action as warranted under law shall be initiated against them.

2. If the candidate(s) conceal any information, his/her selection/admission shall be cancelled ab-initio and fine/penalty shall also be imposed upon him/her as may be deemed proper by the Board in accordance with the laid down rules.
3. The provisionally selected candidate is advised to visit the respective allotted College/Institution for fee and other relevant documents required by the respective College/Institution.
4. It is the sole responsibility of the concerned College/Institution to check and verify the documents and eligibility of the provisionally selected candidate before allowing him to join in his respective College/Institution.
