Pursuant to Notification No.0174-BOPEE of 2024 dated 26.11.2024, the Board has invited offline applications from the willing and eligible NEET- PG/PDCET qualified In-Service Candidates/Doctors of UT of J&K/Ladakh for admission to Post MBBS DNB seats, Post Diploma DNB seats & Post MBBS Diploma seats (Broad Specialty) DNB Courses – 2024.

Further, the inputs were provided to NBEMS on 05-12-2024 & 09-12-2024 and NBEMS vide Ref. No. NBEMC/EDO/2024/0751 Dated: 11-12-2024 handed over the UT Specific Merit List of the candidates for DNB Courses after adding incentive marks, only for consumption/utilization of UT Quota of DNB Courses 2024 Counselling as per the directions of NMC. In view of the above, the JKUT Specific Provisional Merit List of the candidates who have registered themselves with the Board through offline mode for DNB Courses 2024 and have submitted all the requisite documents/category certificates up to the prescribed date is hereby notified as **Annexure-A** to this Notification.

Furthermore, if any candidate who is desirous to remove/make his/her deficiency/objection, if any, as mentioned against his/her name, may do so <u>within three days</u> of the publication of this Notification physically at the BOPEE Offices Jammu/Srinagar during the working days only, failing which no claim whatsoever shall be entertained on this account under any circumstances.

#### Note:

- 1. The candidate(s) who fails to submit his/her deficient document(s) as shown against their name in the **Annexure A** upto the specified days as mentioned in the Notification due to obvious reasons, he/she shall, however, still be provisionally allowed to participate in the counselling process on his/her own risk and responsibility which shall further be subjected to the condition that if he/she is Provisionally Selected in that case he shall have to mandatorily produce all the documents including the deficient documents in the respective allotted Colleges at the time of admission, otherwise the admission of such candidate(s) shall be deemed to have been cancelled **ab-initio**.
- 2. The JKUT Specific Provisional Merit List for DNB Courses 2024 has been prepared by NBEMS is applicable/used only for the allotment of seats specifically for the

- candidates who have applied for DNB courses for the session 2024-25 and the same shall not be considered for the allotment of seats for MD/MS Course 2024-25.
- 3. No deficient documents shall be accepted by the Board through the E-mail or WhatsApp.
- 4. The Annexures A to this Notification shall only remain available on the official website of the Board viz. www.jkbopee.gov.in
- 5. All the eligible candidates are advised to remain in touch with the J&K BOPEE website for day-to-day updates/counseling schedule on the subject as no E-mail or SMS message(s) or telephonic calls shall be sent by the Board in this regard.

The other Terms and Conditions shall, however, remain the same as notified by the Board in the Notifications/Notices issued from time to time in this regard.
