Consequent upon the conclusion of all the rounds of counselling for admission to BAMS/BUMS/ BPT and BHMS Courses- 2024 in various Government/Private Colleges/Institutions of UT of J&K a number of seats in various college/institutions are still vacant. In order to fill up all those seats including AIQ seats in BHMS it is hereby notified for the information of all the concerned candidates that Board shall conduct the Special Stray Round of physical counseling for admission to BAMS/BUMS/ BPT and BHMS Courses- 2024 in various Government/Private Colleges/Institutions of UT of J&K on **19-12-2024 (Thursday)**.

The following procedure shall be adopted on the day of counseling:

1. The eligible and willing candidates shall have to report at the BOPEE offices Jammu/Srinagar for Registration/Attendance and fulfillment of other formalities, from 08:30 a.m. to 10:00 a.m. on the day/date of counseling.
2. The candidate who got seat in any previous rounds of counseling shall not be eligible to participate in this round of counseling.
3. The candidate who did not get any seat or opted CAN/SNA in the previous rounds of counseling shall be eligible to participate in this round of counseling.
4. The candidates participating 1st time shall have to pay the counseling fee of Rs 1500/- through POS machine available at BOPEE office Jammu/Srinagar using their Debit/Credit Card.
5. The Board shall first conduct the counseling of Reserved Category candidates and if any reserved category seat(s) remains unfilled due to non-availability of eligible candidates, then those seats shall be converted into open merit in terms of Section 9(2) of J&K Reservation Act, 2004 and shall be filled up accordingly as per merit.
6. The Seat Matrix shall be uploaded on the website of the Board one day prior to the day of Counselling.

The other Terms and Conditions shall, however, remain the same as contained in the e-Information Brochure, Notifications and Notices issued by the Board from time to time in this regard.
