Notification No. 001-BOPEE of 2025 Dated 09-01-2025

It is hereby notified for the information of all the candidates concerned that as per decision taken by MoHF in consultation with NMC, the percentile for NEET PG counselling 2024 has been lowered and the eligibility is as follows:

- **Open Merit (including JKPM/CDP/ Sports)/EWS=15 percentile and above** will be eligible to participate in counselling
- **SC/ST1/STII/OBC/ALC/IB/RBA (including JKPM/CDP/Sports)=10 percentile and above** will be eligible to participate in counselling

The candidates who fall within the ambit of said revised percentile and are willing to participate in the subsequent round of counseling against the seats that have remained unfilled during previous round of counseling or the seats that are vacant due to resignations are advised to apply as per **Annexure-A** to this Notification and submit all the requisite documents as mentioned in Notification No. 121-BOPEE of 2024 dated 27-09-2024 physically at BOPEE office Jammu/Srinagar w.e.f. **10-01-2025 to 12-01-2025**. The eligible candidate, who has not registered earlier vide Notification No. 121-BOPEE of 2024 dated 27-09-2024 but wants to be considered himself/herself against the unfilled seat/seats may also submit their documents physically at BOPEE office Jammu/Srinagar for registration within the prescribed time schedule indicated here in above.

Note:

1. Mere registration by the candidates does not confer any right on them to have a claim on any vacant seat(s) which as of now are to be filled up based on the merit/preference from the eligible/registered candidates.
2. The candidates should go through all relevant Notifications/Notices along with the e- Information Brochure notified by the Board.
3. The candidates who are already registered vide Notification No. 121-BOPEE of 2024 dated 27-09-2024 need not to apply afresh.
4. Seat Matrix shall be uploaded a day before the start of counseling.

5. The other terms and conditions remain the same as contained in the e-information Brochure, Notifications/ Notices issued by the Board from time to time in this regard.
