Subject: Admission of Dr Gaznufar Yousaf khan in PG Course of MD-Psychiatry at Sher-I-Kashmir Institute of Medical Sciences, Srinagar for Academic Year 2024-25 on creation of One Supernumerary seat (purely one-time measure) by National Medical Commission in compliance of Order of Hon'ble High Court of Jammu & Kashmir and Ladakh {CCP no. 367/2024 in WP(C) no. 2233/2023} dated 30-12-2024.

Whereas, in reference to Letter No. BOPEE-Leg/22/2023(E7322284) dated: 28-11-2024, it was conveyed to the National Medical Commission (NMC) that some of the NEET aspirants of MD/MS/PGD Courses 2023 filed writ petition WP(C) No. 2233/2023 titled Nadeem-Ur-Rehman vs UT of J&K & Ors. before the Hon'ble High Court of Jammu & Kashmir and Ladakh in 2023, seeking various relief(s) and the said case was disposed of by Hon'ble High Court on 08-11-2023 with the directions to keep one seat reserved each for four petitioners in the next session in the disciplines and institutions as mentioned in the judgement.

Whereas, the above quoted order /judgement dated 08.11.2023 was assailed by the UT of J&K, by way of LPA no. 283/2023, titled UT of J&K and others Vs. Nadeem-Ur-Rehman and Others. And some of the petitioners in WP (C) no. 2233/2023 also filed LPA No. 266/2023 against the said judgement, titled Nadeem-Ur-Rehman vs UT of J&K & Ors. Both the above-mentioned appeals came to be clubbed together and vide judgement dated 22.11.2024, the Division Bench of Hon'ble High Court of J&K and Ladakh (at Srinagar) has been pleased to modify the judgement dated 08.11.2023. The Hon'ble High Court with the modification of direction no. (II) of the impugned judgement, upheld the judgement passed by the Writ Court.

Whereas, in compliance to the above referred judgment by the Hon'ble High Court of J&K and Ladakh at Srinagar, National Medical Commission vide letter no. M-15011/01/2025/NMC/PGMARB- Court Case (e ID – 8314332) dated 13-01-2025 created One

Supernumerary seat (purely one-time measure) in PG Course of MD-Psychiatry at Sher-I-Kashmir Institute of Medical Sciences, Srinagar for Academic Year 2024-25.

Whereas, **Dr Gaznufar Yousuf Khan S/O Mohammad Yousuf Khan R/O Dalwaxch Gagigund Anantnag** petitioner at S. no. 10 of the writ petition no. 2233/2023, along with other petitioners at S.No. 9,11 &12 was held entitled to admission in the next academic session by the Hon'ble Court in its judgement passed on 08.11.23 and 22-11-2024.

Whereas, the petitioners at S.No. 9, 11 &12 have also been figured in MD/MS/PGD 2024 Provisional merit List with UT Rank 275/RBA, 20/RBA/OM and 120/OM and during counselling process got selected in the disciplines of MD-General Medicine-GMC Jammu, MD Radiodiagnosis/Radiology-GMC, Jammu and MS Orthopedics-GMC Jammu respectively as per their merit and preferences. The petitioners have joined the allotted colleges except Dr Gaznufar Yousaf Khan NEET PG 2023 candidate bearing Roll No. 23661057282, NEET Rank 39145 Category RBA.

Now, therefore, in consonance with the above referred references and in compliance of the orders passed by the Hon'ble Court, I am directed to convey **Dr Gaznufar Yousuf Khan S/O Mohammad Yousuf Khan R/O Dalwaxch Gagigund Anantnag** petitioner at S. no. 10 of the writ petition no. 2233/2023 to join by or before **24-01-2025 upto 4:00 pm** positively at Sher-I-Kashmir Institute of Medical Sciences, Srinagar to the one supernumerary seat created by NMC in PG Course of MD-Psychiatry for the session 2024-25.

Note:

1. It shall be the sole responsibility of the College/ Institution concerned to ensure proper checking /verification of documents/ eligibility as per the guidelines of MCI/NMC before the candidate is allowed to join the course, he/she is provisionally selected for.
