Subject: Filling up of one (01) OBC seat in MD Anaesthesia in GMC Srinagar.

Notification No. 2 –BÖPEE of 2025 Dated: 12 –03-2025

Whereas, the Board vide Notification No. dated 29-11-2024 released the Provisional Selection List for NEET PG (MD/MS/PGD) Courses-2024 after conducting the 1st round of online counseling, wherein one of the candidate namely PALWASHA AEJAZ got seat in MD-Anaesthesia in GMC Srinagar under OBC category; and

Whereas, GMC Srinagar vide letter no. GMCS/Acad/SS/7774/MC dated 16-12-2024 had submitted the list of resigned candidates for MD/MS/PGD Course-2024; and

Whereas, the Board published the Provisional Selection List of MD/MS/PGD courses-2024 after conducting 2nd round of physical counseling vide its Notification No. 194-BOPEE of 2024 dated 18-12-2024; and

Whereas, GMC Srinagar vide letter no. GMCS/Acad/SS/7821/MC dated 21-12-2024 submitted the resignation list of candidates after 2nd round of counseling; and

Whereas, the Board published the Provisional Selection List of MD/MS/PGD Courses-2024 after conducting the 3rd round of counseling vide Notification NO. 008-BOPEE of 2025 dated 30-01-2025; and

Whereas, in mop-round of counseling and in accordance with Section 9(2) of J&K Reservation Act, 2004 the reserved category seat(s) that remained unfilled due to non-availability of eligible candidates had been converted into Open Merit and filled up as per merit. The Provisional Selection List of Mop-Up Round of Physical Counseling had been published on 21-02-2025 vide Notification No. 015-BOPEE of 2024; and

Whereas, the Board had conducted the stray round of counseling for MD/MS/PGD Courses-2024 whose Provisional Selection List was published vide Notification No. 17-BOPEE of 2025 dated 25-02-2025; and

Whereas, GMC Srinagar vide Letter No. GMCS/Acad/SS/10034/MC dated 04-03-2025 intimated the Board regarding the resignation of one candidate namely PALWASHA AEJAZ in MD-Anaesthesia under OBC category on 04-03-2025 only, which was supposed to be intimated immediately by GMC Srinagar after second round of counselling; and

Whereas, the Board vide letter no. BOPEE-Exam/25/2025(7660050) dated 06-03-2025 sought clarification from GMC Srinagar regarding the cause of delay for intimation in submission of resignation and if any malafide is involved; and

Whereas, GMC Srinagar vide letter no. GMCS/Acad/SS/10034-39 dated 07-03-2025 after getting the matter examined through Committee, clarified same and admitted that error had been occurred at their end and assured the Board that the same will not be repeated in future and it was oversight and no malafide is involved.

Now, in view of the above facts, the Board decided to conduct a separate round of counseling for filling said vacant MD Anaesthesia seat under OBC Category. The Notification to this effect shall be published on the official website of the Board in due course of time. Moreover, only those candidates, who were eligible during 2nd round and subsequent rounds of counselings for this one seat under OBC category as per their merit respectively, shall be eligible to participate in this round of counselling and if OBC candidate is not found/available, then the same shall be converted to Open Merit and allotted as per the merit.
