It shall be the sole responsibility of the Colleges/ Institutions concerned to ensure proper checking/verification of documents/ eligibility as per the guidelines of MCI/NMC before the candidate is allowed to join the course, he/she is provisionally selected for.

The Colleges/ Institutions shall submit the shortfall, if any, to the BOPEE Office, Jammu/Srinagar upto **5.00 PM on 20.03.2025** through e-mail jakbopee@gmail.com / helpdeskjakbopee@gmail.com / coejakbopee@gmail.com.

The admission of the candidates allotted seats during this special stray round of counselling is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false/fabricated, and action, as warranted under law, shall be initiated against such candidates.

The other Terms and Conditions shall, however, remain the same as notified by the Board in the e-Information Brochure and Notifications/Notices issued from time to time in this regard.

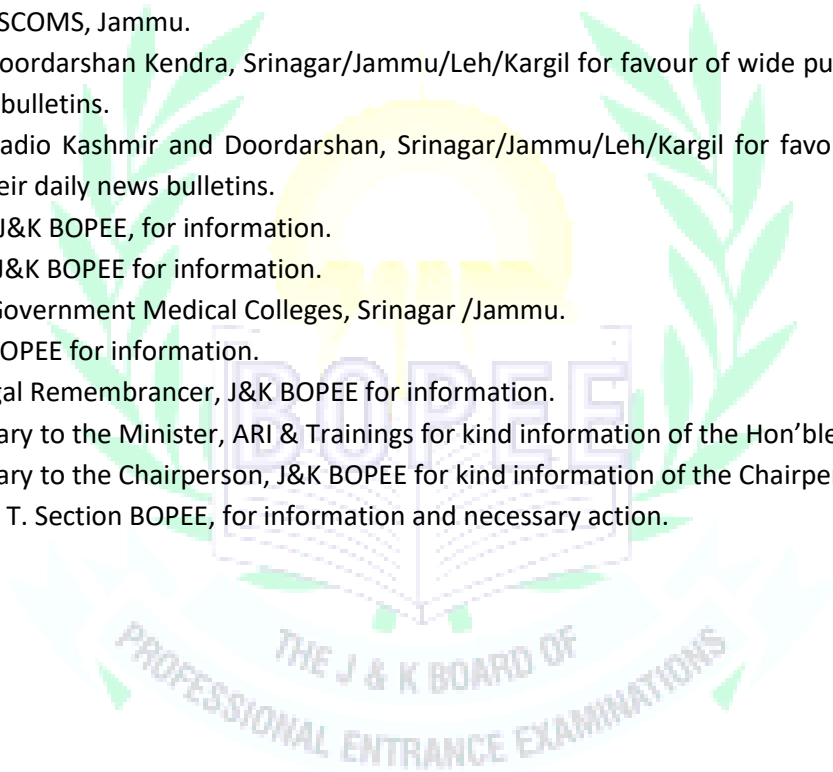
