Whereas, consequent upon counselling held on 13-05-2018, unfilled seat of MD Pathology in ASCOMS under Hindu Minority Quota, was notified to be filled vide Notification No. 036-BOPEE of 2018 dated 13-05-2018 and again vide Notice No. 042-BOPEE of 2018 dated 14-05-2018; and


Whereas, no eligible/willing candidates reported in the BOPEE office on 15-05-2018 upto 2.00 p.m.; and

Whereas, matter has been examined further.

Now, therefore:-

- i) the candidates who have qualified the NEET examination in OM with cut off score of 262 or above and who have not registered in the BOPEE Office so far, if they choose to decide to register themselves in the BOPEE Office, Jammu/Srinagar on 16-05-2018 upto 12.00 noon approach to BOPEE Office for registration and verification of documents/other certificates necessary for consideration under Hindu Minority Quota so that the eligible and willing candidates are considered against the said available seat;
- ii) as an abundant caution, in case the seat still remains vacant and subject to no objection from the ASCOMS to fill up the said seat from eligible candidates belonging to other communities, who have not been allotted a seat so far and are willing to compete for the said seat may also register themselves with the BOPEE office at Srinagar/Jammu so that in case the seat remains vacant and the management desires to fill up the same from other communities, such candidate shall be called for counselling at a short notice. This shall, however, not confer any right upon them to claim the said seat, which shall be subject to the conditions contained hereinabove.
