Filling up of reserved SC seat MD Anesthesiology in GMC, Jammu – dismissal of OWP No. 927/2018.

## NOTIFICATION NO. 3 9 OF 2018 DATED 16-05-2018

Whereas, one seat of MD, Anesthesiology in GMC, Jammu under Scheduled Caste category could not be filled up during the counselling held on 10-05-2018 as the seat was reserved by the Hon'ble High Court vide its direction dated 10-05- 2018 in the case titled Dr. Akhil Kumar Gupta Vs. State and Ors. in OWP No. 927/2018; and

Whereas, Ld. Advocate, BOPEE has informed that the Hon'ble High Court has dismissed the OWP No. 927/2018 filed by Dr. Akhil Kumar Gupta vide its order dated 14-05-2018; and

Whereas, since the seat could not be filled up during the counselling of SC category candidates on 10-05-2018, therefore, Board has decided to call the SC category candidates, who have been allotted a seat/upgraded under SC category on 10-05-2018 for review counselling so that before the seat could be converted into OM, eligible SC category candidates are given an opportunity to compete for the same.

Now, therefore, it is hereby notified that SC category candidates who participated in the counselling on 10-05-2018 and those who were allotted/upgraded as the case may be and those who had registered themselves on the said date but did not get a seat due to seat not available may, appear in the BOPEE Office, Jammu/Srinagar for registration and counselling on 17-05-2018 before the seat is converted into OM. The candidates should be available in the BOPEE Office at 9.00 a.m. for registration and the counselling if required shall be held upto 11.30 a.m. after which this seat or any consequential seat that may become vacant shall be treated as OM seat and action taken accordingly as per law. The candidates, if any, upgraded or allotted a seat shall have to join the upgraded/allotted college within one day i.e latest upto 18-05-2018 (4.00 p.m.).

Note:-

In case of non availability of any SC category candidate, the seat shall be converted into OM and no counselling shall be held in the BOPEE Office for such a seat. However, a panel against the unfilled seats in accordance with MCI Regulations by order of merit shall be forwarded to the concerned College/Institution.
