The last date for submission of tender documents for procurement of above items by the Board of Professional Entrance Examinations, J&K which was earlier fixed as 06-12-2017 has now been further extended upto 18-12-2017 (5.00 P.M) .

The modifications carried out in tender notice no. 1/Computer/HW/2017 dated 18-10-2017, as made vide notice No. 77-BOPEE of 2017 dated 20-11-2017 shall remain the same which are reproduced as under:-

1. The intending tenderers can submit tender either for all the items or for specific items;
2. The earnest money shall be as under:-
  - a) For all in one Desktop Computers Rs.36,000/-
  - b) Network printers-cum-photocopier Rs.6,000/-
  - c) Document scanners Rs.4,500/-
  - d) Routers Rs.3,000/-All items Rs.50, 000/-
3. The turnover shall be Rs.15 lacs per year or Rs.45 lacs for the last 3 years for all the item(s); However, in case of a, b, c & d above, the earnest money shall be Rs.7.00 lacs, Rs.2.00 lacs, Rs. 1.00 lac and Rs.75,000/- respectively on annual basis or Rs. 21 lacs, Rs.6 lacs, Rs.3 lacs and Rs.2.25 lacs respectively for the last 3 years.
4. Any tenderer who has already deposited the tender upto 18<sup>th</sup> Nov. 2017 shall have the option either to withdraw the tender and submit the fresh tender or retain the tender already submitted by him.

It has been decided to hold a conference of intending tenderers who wish to participate in the process, on 11-12-2017 at 11 A.M in the BOPEE office , 4<sup>th</sup> Floor Bahu Plaza, Jammu for clarification/consideration of suggestion, if any.
