Consequent upon completion of second round of counselling of NEET UG 2018, and issuance of the above Notifications dated 25-07-2018, 26-07-2018 and 27-07-2018, and the shortfall received from Government/Private medical/dental colleges, the mopping up round of counselling (physical) for filling up of the vacant seats in Government/Private Medical/Dental Colleges shall be conducted on 5th August, 2018 as already notified vide Notification No. 082-BOPEE of 2018 dated 30-07-2018 in the Board Office Jammu/Srinagar.

- i) desirous of participating in the counselling process shall report in the BOPEE Office, Jammu/Srinagar for registration on the date of counselling viz 05-08-2018 from 9.00 a.m to 10.30 a.m.;
- participating for the first time shall have to deposit a fee of Rs.1500/- through POS machines available in BOPEE Offices before they are allowed to participate in the counselling;
- iii) shall have to submit fresh preferences on the date of counselling;
- iv) are advised to go through the Information Brochure. Other conditions mentioned there but not mentioned above shall apply;
- v) who figure in the State Merit List/those who registered subsequently in pursuance of Notification No. 070-BOPEE of 2018 dated 17-07-2018; and



vi) Those who have registered under Hindu Minority Quota shall be eligible for consideration against such quota.

Note:-

The candidates should weigh their options of allotment of seat carefully before formally approaching the Board for participation in the second round of counselling with a view to avoid un-necessary rush of candidates during the process of counselling. Since the rank has been notified earlier and the availability of seats is now notified in advance, therefore, the candidates can better visualize the prospect of allotment of seat.
