Subject:- NEET UG 2018 (mop up round of MBBS) and first mop up round for BDS.

Notification No.082-BOPEE of 2018 Dated 30-07-2018

Subject to the shortfall of MBBS/BDS, if any, reported by the Government/Private Medical/Dental Colleges/Institutions, the mop up round in NEET UG, 2018 for such seats shall be conducted in the Board Office, Srinagar/Jammu **on 5th August, 2018**. The candidates desirous to participate against the seats which may become available after the shortfall is received from the colleges, are advised to remain in touch with the BOPEE website www.jkbopee.gov.in and only report for participation in the mopping up round if the seats are available. Such seats shall be notified and shall be available on the website of the BOPEE.

The candidates should weigh their options of allotment of seat carefully before formally approaching the Board for participation in the mopping up round of counselling with a view to avoid un-necessary rush of candidates during the process of counselling. Since the rank has been notified earlier and the availability of seats will be notified in advance, therefore, the candidates can better visualize the prospect of allotment of seat.

The candidates are also advised to go through the Information Brochure for further details.

As the DCI Regulations provide for second mop up round, any seat remaining unfilled in the Dental Colleges even after the first mop up round scheduled for 5th August, 2018 shall be filled up subsequently in accordance with the schedule notified by the DCI.

The candidates shall report in the BOPEE Office from at 9.00 a.m. to 10-30 a.m. on 05-08-2018 for registration.

Note:-



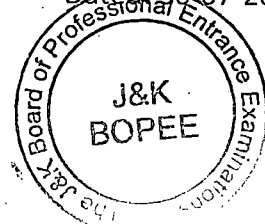
