Subject:- Disposal of Representations received by the Board against Notification no. 59 – BOPEE of 2018 Dated 24-06-2018

Whereas, while notifying the allotment list of candidates for engineering seats in accordance with the rules vide notification 59-BOPEE of 2018 Dated 24-06-2018, the candidates aggrieved of the allotment were given an opportunity to make representation up to 26-06-2018, if they choose to do so:

Whereas, the Board has received nine (09) representations from the candidates on the following:-

- A. Six (06) candidates have requested that they should be considered for change of college/Stream.
- B. One candidate bearing Rank 4516 claims that he should have been allotted seat under RBA in GCET Jammu/Ganderbal/SSM instead of BCET, Samba.
- C. One candidate having Rank 276 claims that a candidate with lower merit than him has been allotted Computer stream in OM instead of Mechanical Stream.
- D. One candidate claims that Reservation Rules have not been properly applied to the SC category in the allotment seat.

Whereas, these representations have been examined in accordance with the rules and it has been observed as under:

- I. The candidates have been allotted the seats purely on the basis of merit cum preferences and after due application of reservation rules.
- II. The change of college/discipline cannot be done by the Board except during upgradation round that too on the basis of merit cum preferences and availability of seats.
- III. The candidate bearing Rank 4516 has been rightly allotted the stream/college on the basis of rules including application of rule 17 of SRO 294 of 2005.

Now, having considered the representations made by the candidates, that too without any documentary material/proof in support of their claim, the same have been examined and found void of any of any merit. As such, the allotments made vide notification No. 59-BOPEE of 2018 Dated 24-06-2018 do not require any review and consideration.
