The Ministry of Ayush, Government of India have clarified vide their communication dated 11-6-2018 and Letter dated 26-6-2018 that admission to Ayush Courses shall be made strictly on the basis of NEET eligibility by using the Merit list of the NEET qualified candidates. Therefore the cut off merit for filling up of the seats in Ayush courses viz BAMS, BUMS and BPT shall be as under:-

**Upto 119**

**Reserved Categories (SC,ST, RBA, ALC, OSC)**

**Up to 96**

It is further reiterated that 65 " Marks" mentioned in Notice No. 69-BOPEE of 2018 dated 4-8-2018 is only for purposes of registration and shall not be construed as eligibility to participate in the counselling for which the above score shall be valid unless otherwise provided for by the Ministry of Ayush.

It is also notified that the above score shall be applicable to the seats as may be filled by the private colleges under management quota in accordance with Notice No. 71-BOPEE of 2018 Dated: 9-8-2018.
