## Notification No. 063-BOPEE of 2018 Dated 08-07-2018

Whereas, while notifying the list of candidates recommended for admission provisionally to various medical/dental institutions of the State vide Notification No. 062-BOPEE of 2018 dated 06-07-2018, the candidates were given two days time to make representations, if any, upto 08-07-2018 along with documentary evidence: and

Whereas, following representations have been received from P&B (OM) category candidates, who have not been allotted any seat in ASCOMS under OM category:-

Whereas, during discussions, before the finalization of draft list, the Board was of the view that it would not be possible for the candidates with a meager income of Rs.70000/- per annum i.e. Rs.6000/- per month, and by belonging to the lowest income strata, to pay the annual fee of Rs.4.50 lakhs if they are considered under OM category in ASCOMS; and

Whereas, the above candidates have preferred representations requesting therein that they may be considered under OM seat in ASCOMS in view of their superior merit as they would be taking loans/borrowings to pursue the studies in MBBS course in ASCOMS; and

Whereas, the matter has been examined in the Board and it has been decided that:-

- such candidates who fall within the cut off merit under ASCOMS OM category notwithstanding their P&B status be given an opportunity of seeking admission subject to their merit and preference;
- The P&B certificates of such candidates issued by the concerned Tehsildars shall be got verified through District Magistrates to ensure that genuine candidates are given P&B certificates and there is no misuse of such concession provided in the Private Medical Colleges and also to ensure that the poorest of poor candidates avail the benefit of this concession.

Now, therefore, having considered the representations, the admission list notified vide Notification No. 062-BOPEE of 2018 dated 06-07-2018 is hereby modified to the extent of inclusion of the five representing candidates as mentioned in para 2 of this Notification in the admission list of ASCOMS and consequent deletion of last five candidates with **State Ranks 379, 380, 381, 387 and 388** from the said admission list. The position of other candidates shall remain the same.

It is further notified that:-

1) The candidates, who have now been included in the list shall be required to complete the admission formalities under the terms and conditions as contained in Notification No. 062-BOPEE of 2018 dated 06-07-2018;

- 2) They shall, however, have to join the college necessarily and in case of their non joining the Board reserves the right to impose a penalty upon them to the extent and manner as may be considered expedient by the Board;
- 3) All the candidates shall take admission in the respective colleges upto 15-07-2018 as notified by the Board vide Notification No. 062-BOPEE of 2018 dated 06-07-2018;
- 4) The candidates who have been excluded as a consequence of above inclusions and subject to their merit cum preference shall be considered for allotment of seats in IDS for which they may approach the Board so that the same is considered accordingly.

Note:-

- 1. The candidate with State Rank 388, who has been excluded as a consequence of above from ASCOMS has also indicated his preference for IDS, Jammu. Therefore, one seat in IDS, Jammu shall remain unfilled by deletion of the last candidate with State Rank 644, which shall be utilized for consideration of the candidate with State Rank 388 if he approaches the Board for the purpose. Other terms and conditions shall remain the same as notified in Notification No. 062-BOPEE of 2018 dated 06-07-2018;
- 2. The P&B certificates of such candidates who have been included in ASCOMS as above shall be got verified through District Magistrates to ensure that genuine candidates are given P&B certificates and there is no misuse of such concession provided in the Private Medical Colleges and also to ensure that the poorest of poor candidates avail the benefit of this concession.
- 3. In addition to the above representations one more representation was received with the State Rank 430 requesting for similar consideration. Since he did not fall in the cut off merit of ASCOMS as such same has been considered and rejected.
