

Consequent upon the shortfall as may be received after the last date of joining of candidates allotted seats under BUMS/BAMS/BPT vide Notification No. 107-0BOPEE of 2018 dated 24-09-2018, pursuant to the second round of counselling (physical) held on 24-09-2018 the third round of counselling (physical) shall be held on 08-10-2018 in the Board Office Jammu/Srinagar. However, tentatively following seats have been reported to be unfilled as on 01-10-2018:-

The candidates:-

- allotted Government/Private Colleges in the first/second round of online/physical counselling but who have not joined because of one or the other reason shall be given an opportunity to compete against seats on the basis of merit cum preference;
- ii) who figure in the Provisional State Merit List (PSML) in terms of Notice No. 78-BOPEE of 2018 dated 28-08-2018 but have not participated in the first/second round of online/physical counselling shall be eligible to participate in the third round of counselling(physical);
- iii) who did not get a seat during online/physical round of counselling shall also be eligible to participate in the counselling;
- iv) desirous of participating in the counselling process shall report in the BOPEE Office, Jammu/Srinagar for registration on the date of counselling viz 08-10-2018 at 9.00 a.m;

- participating for the first time shall have to deposit a fee of Rs.1500/- through POS machines available in BOPEE Offices before they are allowed to participate in the counselling;
- vi) shall have to submit fresh preferences on the date of counselling;
- vii) who have not registered themselves earlier shall also be eligible to compete provided they register themselves upto 6th of October, 2018 during office hours. They shall have to submit a registration form and copies of all documents in the Board Office, Jammu/Srinagar and produce original documents. The cut off merit shall however, remain the same as notified earlier i.e. 119 for OM and 96 for reserved category candidates;
- viii) are advised to go through the Information Brochure. Other conditions mentioned there but not mentioned above shall apply;

Note:-

- (A) The seats in Jammu Institute of Ayurveda & Research(JIAR), Jammu, which have not been filled during the first/second round of online/physical counselling in light of Government of India, Ministry of AYUSH communication dated 13-08-2018 shall continue to remain on hold till a clarification is received from the Ministry. Therefore, these seats shall not be filled up during the second round of counselling unless otherwise provided by the Government of India;
- (B) The candidates are advised to remain in touch with the BOPEE website www.jkbopee.gov.in/www.jakbopee.org. for updated seat matrix etc., which shall be uploaded after receipt of the shortfall from the Colleges. The above seats are tentative and subject to change;
- (C) The reserved category seats remaining unfilled during the third round shall be filled up from OM candidates during the process of counselling itself on the said date.
