**Subject: Unfair means case against Ms. Vaishali Sharma D/o Sh. Darshan Lal R/o Rakh Nagbani, Sangrampur, Jammu in B.Ed. Jammu (2018) Entrance Test held on 24-06-2018.**

Whereas, Ms Vaishali Sharma D/o Sh. Darshan Lal R/o Rakh Nagbani, Sangrampur, Jammu appeared in B.Ed Entrance Test under Roll No. 11032143, which was held in Govt. College of Education, Canal Road, Jammu (Venue Code JC 044 Hall) on 24.06.2018; and

Whereas, a case of unfair means was reported against Ms Vaishali Sharma, by the Superintendent of the said Examination Centre in which; and

Whereas, as reported by the Superintendent, Ms Vaishali Sharma, was caught using Mobile Phone No.9149446154 (Samsung J5P) during examination period, the use of which was not allowed inside the premises of the examination centre as per guidelines notified vide notification No. 054-BOPEE of 2018 dated 15.06.2018, whereunder it was clearly stated that no electronic devices would be allowed inside the premises of the examination centre and if any candidate is found carrying any one of the devices in the test centre, his/ her candidature would be cancelled including imposition of ban for future examination/ selection; and

Whereas, in terms of Rule 26 of SRO of 168 of 10.06.2014 and after having satisfied about the existence of a prima facie case, a show cause notice dated 01-08-2018 was served to Ms Vaishali Sharma to explain her conduct in the matter up to 09.08.2018 at 11.30 AM before the Board at Srinagar either in person or through an authorized person, failing which it shall be presumed that she had nothing to say in her defence and an action as warranted as per Rules shall be taken against her; and

Whereas, Ms Vaishali Sharma vide her application received by the Board on 13.08.2018 requested to change the venue from Srinagar to Jammu to explain her conduct before the Board authorities; and


Whereas, the Board vide another show cause Notice dated 20.08.2018 informed that her request for change of venue has not been accepted as the Board was Headquartered at Srinagar and could not move to Jammu for the purpose; and

Whereas, another opportunity was given to her to appear before the Board on 31.08.2018 at 11.30 AM positively to explain her conduct either in person or through an authorized person; and

Whereas, Ms Vaishali Sharma failed to respond to the 2<sup>nd</sup> show cause notice also served to her despite given reasonable opportunity of being heard and by granting extension in time also;

Now, therefore, having considered the matter in its totality and the material available on record, Ms Vaishali Sharma, having Roll No. 11032143, who had appeared in B.Ed. Jammu Entrance Examination on 24.06.2018 and was found to have indulged in Unfairmeans by using her mobile phone No. 9149446154 and being a first time offender is declared as having failed in B.Ed. examination 2018 and also disqualified for appearing in one such examination held by the Board in future in terms of rule 27 (1) of SRO 168 of 2014. The mobile phone (Model Samsung J5P) of Ms. Vaishali Sharma bearing mobile no. 9149446154, Jio Sim No. 89918600300000502356, IME 351676/09/203693/0 and IME 351677/09/203693/8 shall remain seized.
