DATED 02-01-2019**

Pursuant to Notification No. 121-BOPEE of 2018 dated 22-12-2018, and on the basis of the counselling conducted on 27-12-2018 in pursuance of Hon'ble High Court orders dated 20-12-2018, list of candidates selected provisionally for admission to MD/MS Ayurveda Course in JIAR, Jammu was notified vide Notification No. 123-BOPEE of 2018 dated 27-12-2018. The College has reported a shortfall of 5 seats (Kaya Chitiksa =2, Shalya Tantra = 2, Kriya Sharir = 1) which have become available due to non joining etc. Any candidate eligible and willing to take admission in the said college in terms of Notification No. 121-BOPEE of 2018 dated 22-12-2018 or interested in upgradation may approach to the BOPEE Office, Jammu/Srinagar for counselling on 03-01-2019. The candidates selected shall have to join by 3rd January, 2019 after which no counselling shall be conducted.

The other terms and conditions shall remain the same as notified from time to time and vide Notification No. 121-BOPEE of 2018 dated 22-12-2018 and 123-BOPEE of 2018 dated 27-12-2018. The candidates are advised to go through these Notifications, which are available on the website of the BOPEE www.jkbopee.gov.in/www.jakbopee.org.

As notified vide Notification No. 121-BOPEE of 2018 dated 22-12-2018 and Notification No. 123-BOPEE of 2018 dated 27-12-2018, the counselling/admission shall be purely provisional and subject to such other orders as may be passed by the Hon'ble High Court /final outcome of the writ petition No. 2208/2018 tiled Jammu Institute of Ayurveda & Research Vs Union of India & Ors. pending before the Hon'ble High Court at Jammu. The writ petition has been filed by the College against the orders of the Ministry of AYUSH dated 26-09-2018 vide which permission to undertake admission to MD/MS Ayurveda Courses in JIAR has been withdrawn by the Government of India. The said order has been stayed by the Hon'ble High Court but the final orders are yet to be passed by the Hon'ble High Court.

The orders of the Hon'ble High Court dated 20-12-2018, shall be read in detail to the candidates during the process of counselling.
