## NOTIFICATION NO.003-BOPEE OF 2019 DATED 03-01-2019

In pursuance of Notification No. 121-BOPEE of 2018 dated 22-12-2018 and in compliance and with due deference of the orders of the Hon'ble High Court dated 20-12-2018 in the Contempt Petition No. CPOWP 323/2018 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research Vs Union of India & Others, the counselling for the unfilled seats of MD/MS, Ayurveda in JIAR was held on 27-12-2018 in the Board Office at Srinagar/Jammu. Consequent upon the shortfall conveyed by the College as notified also by the Board vide Notification No. 001-BOPEE of 2019 dated 02-01-2019, the counselling for the said seats was held on 03-01-2019 in the Board Office at Srinagar/Jammu, based on which the list of candidates provisionally recommended for admission/upgraded in the MD/MS, Ayurveda course in JIAR is given in the Annexure Á' to this Notification.

The candidates so admitted/upgraded shall have to join the Institution/Courses latest by 3<sup>rd</sup> of January, 2019 (4.00 p.m) as informed to them during the counselling also. The College shall, however, allow the candidates to join the Institution only on production of all original certificates as notified earlier from time to time.

The College shall submit the list of admitted candidates to the BOPEE on **03-01-2019 by 5.00 p.m.** alongwith the documentary evidence of the fee paid by the candidates for record and reference of the Board.

/final outcome of the writ petition No. 2208/2018 tiled Jammu Institute of Ayurveda & Research Vs Union of India & Ors. pending before the Hon'ble High Court at Jammu. The writ petition has been filed by the College against the orders of the Ministry of AYUSH dated 26-09-2018 vide which permission to undertake admission to BAMS/MD/MS Ayurveda Courses in JIAR has been withdrawn by the Government of India. The said order has been stayed by the Hon'ble High Court but the final orders are yet to be passed by the Hon'ble High Court.

The orders of the Hon'ble High Court dated 20-12-2018, have been read in detail to the candidates during the process of counselling.
