NOTICE NO.07 DATED 05-02-2019

Whereas, while inviting online applications for admission to B.Ed. Kashmir (IASE) & B.Ed. Special Education (CRC) Courses-2019 vide Notification No: 004-BOPEE of 2019 dated 12-01-2019, it was, inter alia, laid down that:-

"the eligibility is bare minimum/provisional and shall be subject to such changes/bench marks as may be fixed by the concerned University. The Board shall on receipt of any such communication from the authority/University notify the same, which shall govern the eligibility criteria"

Whereas, the matter was taken up with the Cluster University, Srinagar, who have failed to clarify the matter; and

Whereas, matter has been examined further, in light of other rules on the subject, including the conditions of eligibility for admission as laid down in SRO 294 of 2005 dated 21-10-2005 and the BOPEE Rules and Regulations.

Now, therefore, in amplification of Notification No: 004-BOPEE of 2019 dated: 12-01-2019, the eligibility for candidates for applying for admission to B.Ed. Kashmir (IASE) & B.Ed. Special Education (CRC) Courses-2019, shall and shall be as under:-

- OM (including JKPM/CDP/Sports) candidates should have secured minimum of i) 50% marks in aggregate in the qualifying examination;
- Reserved category (SC/ST/RBA/ALC/OSC)) candidates should have secured ii) minimum of 40% marks in aggregate in the qualifying examination.
