It is hereby notified for the information of the candidates, who have submitted online registration forms and uploaded the documents and figure in the Provisional State Merit List notified vide Notification No. 10-BOPEE of 2019 dated 09-03-2019 and those who may register upto 12-3-2019 and upload the documents in pursuance of Notice No. 19-BOPEE of 2019 dated 11-03-2019 and may finally figure in the updated Provisional State Merit List as may be notified by the Board in due course of time, that the **online filling up of preferences** for allotment of seats shall be as under:-

a)	Mock exercise	14-03-2019
b)	Filling up of the preferences	15-03-2019 to 20-03-2019
c)	Updation/changes of preferences, if any	21-03-2019 upto 4.00 p.m.

It is further, notified that:-

- i) All the candidates, who shall figure in the updated Provisional State Merit List as may be notified by the BOPEE shall be eligible to participate in the online counselling process for MD/MS/PGD seats;
- ii) For MDS candidates the eligibility shall be as under:-

iii) The candidates shall have to pay an online fee of Rs.2000/- during the filling up of the online preference forms, without which they shall not be considered for allotment of a seat.

Note:-

- 1. The candidates, in their own interest, are advised to go through the general technical instructions, as contained in Information Brochure. However, candidates are advised to print one copy of preference form filled in by them for record and reference. No copy be sent to JKBOPEE as otherwise mentioned in the Information Brochure.
- 2. They should also update their preferences if they so desire, only on the date as mentioned above. Board shall not allow any candidate to change the preference, after the prescribed date.
- 3. The tentative operative seat matrix is being uploaded separately. The Government of India/MCI have converted some Diploma seats into PG seats and after updation of the same, the seat matrix will be notified.
- 4. The seats for MDS Course 2019 have been increased by the Government of India from 12 to 18. The tentative distribution of seats for MDS shall be OM = 14, RBA = 2. ST=1, SC=1 in pursuance of distribution SRO 154 of 2009.
- 5. The candidates, who fail to make online payment of fee notwithstanding having filled the preferences and falling in the zone of consideration will not be considered for allotment of the seat.
- 6. The candidates shall have to keep all the documents ready to avoid any delay in the admission process including the NOC in respect of in-service candidates. The candidates failing to produce any of the documents notified from time to time including the NOC from the employer shall not be eligible to join the college/course. The in-service candidates are, therefore, once again advised to apply only in case they are eligible under rules and obtain the NOC.
- 7. Any candidate found ineligible at any stage of counselling/admission shall be debarred from counselling/further admission process as notified from time to time.
- 8. Mere filling up of preferences by candidates shall not confer any right upon them to claim a seat which shall be subject to the conditions contained in the Information Brochure and the subsequent Notifications/Notices issued from time to time.
