Subject: - Filling up of MD/MS Management Seats of Hindu Minority (HM) and Non-Resident Indians (NRI) Quota of ASCOMS, Jammu through Joint Counselling by J&K BOPEE.

All those NEET – PG 2019 eligible candidates, who figure in Provisional State Merit List (PSML) of MD/MS/PG Diploma and are interested in the MD/MS seats of ASCOMS under Hindu Minority and NRI management quota seats are advised to deposit their documents on the prescribed proforma along with all relevant/required documents in BOPEE office Srinagar/Jammu **by or before 8th April, 2019**, the details of which is given below:

Total Management Seats of ASCOMS = 09

- (i) Open Merit (OM)* = 02 (01 = Medicine; 01=Pathology)
- (ii) Hindu Minority (HM)** = 05 (01=Anaesthesiology; 01 = Pathology; 01 = Radio Diagnosis/Radiology; 02 = Surgery)
- (iii) Non-Resident Indians (NRI)*** = 02 (01 = Anaesthesiology; 01 =Medicine)

(* 02 OM seats under management quota shall be filled up on the basis of merit cum preference irrespective of religion/category, etc.).

(** 05 Hindu Minority (HM) seats under management quota shall be filled up from the candidates belonging to Hindu Religion only with the condition that they shall produce a latest relevant document/certificate issued by the concerned competent authority).

(*** 02 NRI seats shall be filled up on the basis of merit cum preferences provided the necessary NRI documents are complete in all respects).

Only such candidates shall be considered under management/NRI/Hindu minority quota who are:

- (i) State subjects under Section - 6 of the Jammu and Kashmir State Constitution;
- (ii) have applied under NEET-PG 2019 and have qualified; and
- (iii) have been found eligible to participate/compete against the State seats;

The eligibility criteria for competing under NRI quota seats shall be as under:-

(a) Where applicant himself/herself is NRI and family originally belongs to J&K

(Category 1);

(b) Children/Ward of NRI who originally belong to State of Jammu and Kashmir

(Category 2);

(c) Any other condition as notified by the Government of India/State Government or any direction given by the Hon'ble Supreme Court to be eligible to compete for such seats.



Documents Required for NRI Category 1 and Category 2 candidates:

- (i) NEET PG Score Card – 2019;
- (ii) NRI certificate issued by the Ministry of External Affairs, Government of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport;
- (iii) NRI Bank Account preferably in the country where the candidate is residing or of NRI Account in India;
- (iv) Copy of Indian Passport;
- (v) Copy of Income Tax Return filed in India, if any;
- (vi) PAN Card No., if any; and
- (vii) State Subject Certificate of the candidate.
- (viii) Any other document as may be required by the Board to its satisfaction.

Category No. 2:

- (i) NEET PG Score Card – 2019;
- (ii) NRI Sponsorship Letter;
- (iii) Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian Embassy Overseas;
- (iv) Bank Statement of the Sponsor;
- (v) Resident/National Certificate or NRI certificate of the sponsor;
- (vi) Pedigree Table/Family Tree establishing relationship of the candidate with the sponsor along with documentary Proof;
- (vii) Employment certificate of the sponsor;
- (viii) PAN Card No., if any of the sponsor;
- (ix) PAN Card No., if any of the candidate/parents;
- (x) Copy of Income Tax Return filed, if any;
- (xi) State Subject of the candidate.

1. The above documents are required in addition to all other documents that the candidates were required to submit as notified in earlier notifications and in conformity with the e- Brochure.
 2. The above category is not priority but for determination of eligibility only and the seats shall be filled up on the basis of NEET Merit/State Rank.
 3. The fee shall be as notified in Information Brochure or as may be notified by the Government from time to time.

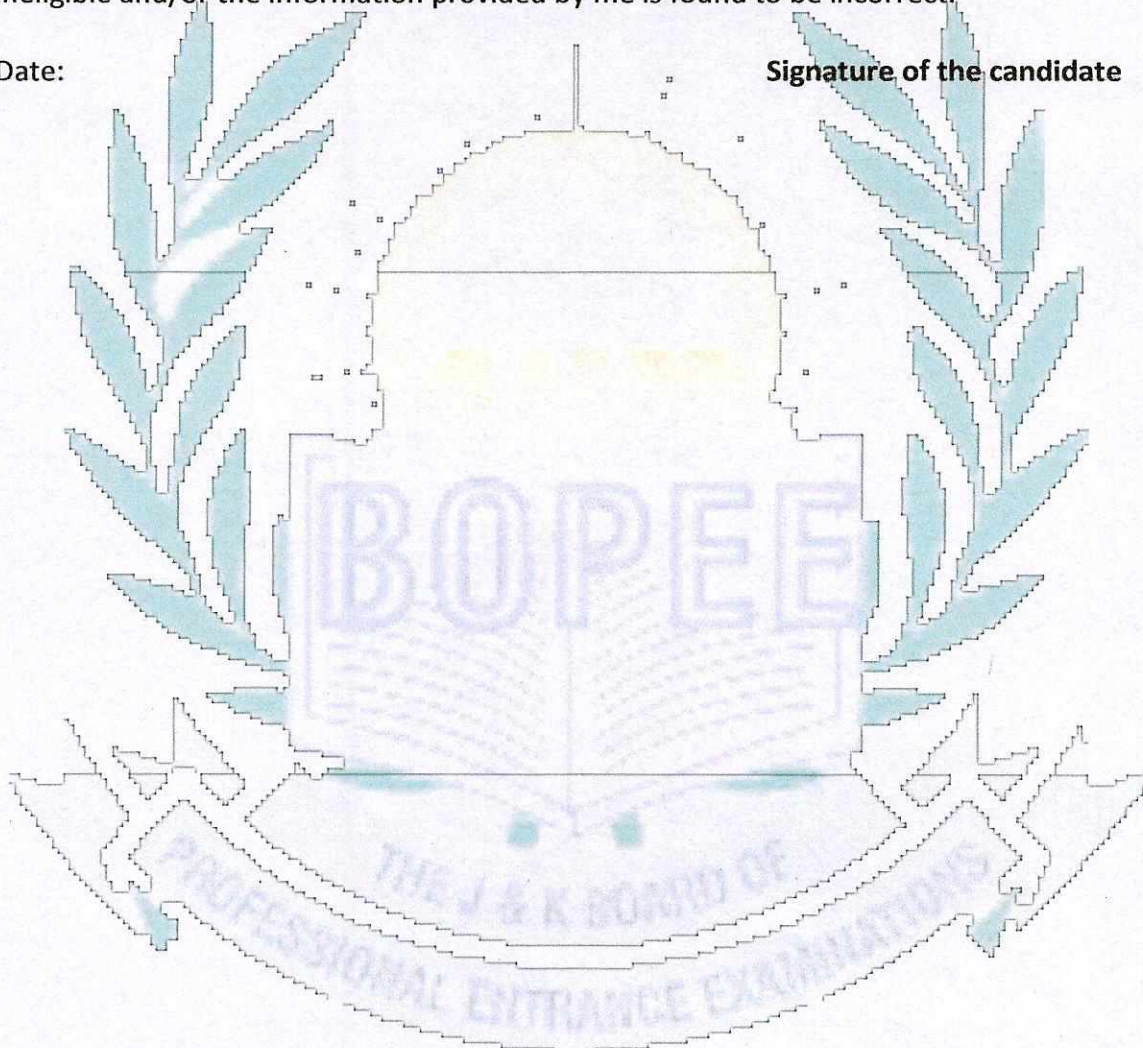
